### 2. Committee Reports and Discussion

### Administration and Organization

- MOU update Paul Penn will help secure the Cal/EPA signature via the Deputy Secretary; Ed will prepare a "CEEIN basics" presentation to support this effort. Need to identify Deputy-level contacts at the remaining agencies that need to sign.
- CEEIN Handbook Ed will be working on the update.
- Roster changes Linda Desai from the Placer Nature Center will join as the Project WILD Coordinator. Because Sandy Derby (California PLT State Coordinator) is an employee of UCANR, she will be moved from CEEIN Partner to CEEIN Member.

### Communications and Outreach

- CEEIN members have submitted 7 proposals for the CSTA Conference,
   October 2-4.
- Cal/EPA Earth Day event on April 22 will include about 35 booths; 16 booths are coordinated by CARB and 8 are CEEIN members. Additional members are invited to participate in the event.
- Sac State's Earth Day celebration will be on April 16; members are invited to give materials to Lesley for display.
- Members expressed renewed interest in an internal CEEIN events calendar. Annie will start the calendar and upload it to Box so that all members can contribute.

# Diversity, Leadership and Legislation

- O AB 988 (Stone) The bill proposes an environmental education grant program using State Parks land. Shannon completed a bill analysis for CDE, which included a recommendation to strengthen the requirements for program quality such that grantees would meet at least three out of seven specified qualities (instead of only one). CEEIN is named in this bill, to be consulted during program development.
- ACR 17 (Chang) The resolution designates April 5-11 as Women and Girls in STEM Week.

## 3. Next Generation Science Standards Group Activity

 Members received an orientation to the CA NGSS as "three-dimensional learning" implementing three elements: science and engineering practices (SEPs), crosscutting concepts, and disciplinary core ideas.

- Christy, Shannon, and Annie led the group in an activity to become more familiar
  with the SEPs featured in the CA NGSS. This activity was designed for
  nonformal environmental education providers and was originally featured at a
  "ChangeScale" workshop in the Bay Area last fall.
- Guidance shared by CEEIN members includes:
  - o Focus on the three elements, not the student's performance expectation.
  - Review the NGSS appendices, which cover grade spans.
  - Use current content to pull in the SEPs and cross-cutting concepts.
  - o Practice the SEPs with existing curriculum, such as the EEI.
- Chris provided an update on CA NGSS implementation
  - o Phase 1 ("Awareness") is nearly complete
  - Phase 2 ("Transition") starts April 13-14, 2015 at CDE. CEEIN members are invited to attend one of these roll-out meetings; please e-mail Chris with the location you would like to attend.
  - o Full implementation is estimated for the 2018-19 or 2019-20 school year.
