# REPORT OF DE MINIMIS WAIVERS

## **Proposed Development**

Construction of a new satellite recycled water treatment plant, including 2,800 linear feet of 8-inch diameter pipeline, diversion from the sewer collection system on Asilomar Avenue and connection back to sewer system adjacent to Sunset Drive, and related site improvements that would provide 125 acrefeet per year of recycled water to replace the potable water supply used for the existing irrigation systems at the Pacific Grove Golf Links and El Carmelo Cemetery near the Point Pinos Lighthouse Reservation in Pacific Grove, Monterey County.

#### **Executive Director's Waiver Determination**

Pursuant to Title 14, Section 13238 of the California Code of Regulations, and based on project plans and information submitted by the Applicant regarding the proposed development, the Executive Director of the California Coastal Commission hereby waives the requirement for a CDP for the following reasons:

The proposed project includes construction of a new satellite recycled water treatment plant and reuse of the existing storage tanks at the site of the retired Point Pinos Wastewater Treatment Plant. The project will treat wastewater diverted from an existing sewer line with a grit removal system, biological filtration system, and disinfection system that uses ultraviolet light methods. The treatment plant will provide up to 125 acre-feet of recycled water that meets California Code of Regulations, Title 22 requirements for unrestricted uses of recycled water. The recycled water would replace the current potable water supply that is used to irrigate the Pacific Grove Golf Links and El Carmelo Cemetery. The project could be expanded to provide up to 600 acre-feet of recycled water, but any expansion would require further environmental review and CDP approval. The project carries out the guidelines set forth in Executive Order B-29-15 that was issued by the Governor of the State of California in response to the Continued State of Emergency due to the ongoing drought. The proposed project would reduce overdrafting of the Carmel River and help the State reach its goal of reducing potable water use by 25 percent within the next year.

The development footprint of the proposed recycled water treatment plant stays within an area of fill that was previously occupied by the retired wastewater treatment plant. Construction of the new pipelines will occur within areas that are currently developed with a public golf course and these areas will be restored to their current condition after construction concludes. Four recorded sites of cultural

significance occur within the Area of Potential Effect of the project, but no significant cultural resources were discovered during an initial survey. The proposed project requires an extended archeological survey for all impacted recorded sites, an archeological monitor during excavation activities, and mandatory work stoppages if any middens or remains are discovered. No special status plant species are located in the areas that will be disturbed during construction, and all nonnative plants within the project area will be removed prior to construction and these areas replanted with appropriate native plant species after construction. The proposed project retains the Monterey Cypress trees that surround the proposed treatment plant site and several new trees will be planted. Although no special status wildlife species or nesting birds have been found, the project requires a seasonal restriction on construction activity during nesting season or a preconstruction survey by a qualified biologist in areas within 300 feet of construction. If any nesting birds are discovered, further mitigation measures will be required.

The existing Monterey Cypress trees provide a visual barrier between the development site and Sunset Drive. All proposed development is limited in height to at or below the height of the existing storage tanks. The existing storage tanks will be repainted to blend into the dune aesthetic and provide further visual camouflage. Security fencing will be placed inside the tree line to block the fence from public view. All other fencing on the project site will be removed. Sunset Drive will remain open during all phases of construction and a Temporary Traffic Handling Plan will ensure that pedestrian and motor traffic will not be substantially disrupted. No coastal access points or recreation areas will be impacted by the development or disrupted during construction.

The proposed project includes other mitigation measures and Best Management Practices (BMPs) to address possible impacts to coastal resources. Erosion and drainage BMPs and Good Housekeeping BMPs are included to protect water quality in the Monterey Bay. No new significant impervious surfaces are included that would impact stormwater runoff at the project site. A site-specific plan for the removal and disposal of any lead will be developed if any lead is discovered during a risk-assessment of the existing storage tanks. Hazardous wastes will not be stored onsite and hazardous material BMPs will be implemented to avoid site contamination.

The proposed project was reviewed and received discretionary approval by the City of Pacific Grove's City Council to ensure conformance with the requirements of the California Environmental Quality Act and certified Land Use Plan. The project has no potential for adverse effects on coastal resources, including public access to the shoreline, and is consistent with Chapter 3 of the Coastal Act.

#### **Proposed Development**

Five year permit to install "no-climb" wire mesh fencing and educational signs to discourage creation of volunteer trails and off-trail use, prevent wind erosion, and to protect the fragile dune ecosystem along three beach access trails at Fort Ord Dunes State Park, Monterey County.

#### **Executive Director's Waiver Determination**

Pursuant to Title 14, Section 13238 of the California Code of Regulations, and based on project plans and information submitted by the Applicant regarding the proposed development, the Executive Director of the California Coastal Commission hereby waives the requirement for a CDP for the following reasons:

Fort Ord Dunes State Park (Park) is home to several rare and endangered species, such as Smith's blue butterfly, Western snowy plover, Monterey spineflower, sand gilia, coast wallflower, and sandmat manzanita. Since opening in 2009, a steady increase in visitation at the Park has led to the creation of volunteer trails and greater dune disturbance and degradation of habitat values. Existing signage and symbolic fencing (low post and cable) have been unsuccessful in discouraging repeated incidences of trespass through sensitive habitat areas, and such trespass is rapidly destabilizing and damaging these areas of the park. The requested fencing and educational signing is necessary to manage access and educate the public on the rare and sensitive nature of the surrounding sand dune habitat and its plant and animal inhabitants. The four-foot-tall wire mesh fencing (2" x 4" squares) will not block public views and will be mounted on wooden poles placed directly into the sand. No concrete is proposed. Poles will be placed to avoid sensitive plant species. An eight-to-twelve-inch gap along the bottom of the fencing will be provided to allow wildlife to pass under the fencing. In sum, the proposed project will safeguard rare and endangered species and their habitat and will not adversely impact coastal resources, consistent with the Coastal Act.

### **Proposed Development**

Installation of a hybrid rock-fall attenuator in each of two chutes adjacent to the existing Alder Creek slide. The new rock-fall drapery system will span from the lower portion of the Alder Creek slide to approximately 310 feet south. In addition, the inlet to the drainage system located below chute 2 will be modified to prevent frequent plugging at Alder Creek, in southern Big Sur, Monterey County.

#### **Executive Director's Waiver Determination**

Pursuant to Title 14, Section 13238 of the California Code of Regulations, and based on project plans and information submitted by the Applicant regarding the proposed development, the Executive Director of the California Coastal Commission hereby waives the requirement for a CDP for the following reasons:

Access to the work area will be via foot trails and aerial lift; no access roads will be constructed. Caltrans estimates that it will take one day to place the drapery onto the newly installed anchoring. The majority of the work will be performed using rope access. The system will incorporate the existing steel cables used in the lower Alder Creek slide system, which will be connected via a new top support cable with new ground anchors established into rock. The attenuators will consist of black PVC-coated double-twisted cable backed with black PVC-coated drapery. The black netting will blend in with the black and grey shale rock in the vicinity of the slide. Existing vegetation will be trimmed and the proposed system will be installed over the top of the trimmed vegetation. The vegetation is expected to rapidly re-grow through the drapery netting and provide additional screening of the rock-fall netting. A redundant inlet in the northbound shoulder will be added to the drainage system to prevent water ponding on the highway. This work will not affect the existing down-drain located west of Highway One. In sum, the proposed project will safeguard motorists and maintain vehicular access along the southern Big Sur coast, and will not adversely impact coastal resources consistent with the Coastal Act.

#### **Proposed Development**

Vegetation management within Arroyo Grande Creek flood control channel, including the surrounding levee, consisting of minor hand trimming of willow root sprouts to preserve channel capacity and encourage canopy growth to provide shade for the creek; minor thinning of woody vegetation, removal of invasive exotic plant species and vegetation along the levee tops for access and maintenance purposes, and trash and debris removal, located in Oceano and Arroyo Grande, San Luis Obispo County.

#### **Executive Director's Waiver Determination**

Pursuant to Title 14, Section 13238 of the California Code of Regulations, and based on project plans and information submitted by the Applicant regarding the proposed development, the Executive Director of the California Coastal Commission hereby waives the requirement for a CDP for the following reasons:

The proposed project will continue efforts to enhance habitat within the creek and riparian corridor while providing for increased channel capacity for water flows and flood control purposes. The project has been designed to avoid adverse impacts to coastal resources by limiting the extent of trimming and vegetation thinning, and limiting such activities to crews using hand tools only. In addition, the project is designed to maintain shade for improved water quality and habitat within the managed channel. Large woody material within the creek channel will be cut or notched and left in the channel to provide woody habitat; only fallen and low overhanging willow branches will be cut and all root balls will be left intact. No heavy machinery will be used within the creek channel and no herbicides will be used. Crews will remove invasive exotic species, particularly castor bean, to improve riparian habitat. Biological monitors will be in place for the duration of the project to ensure project activities do not disrupt any habitat areas.
