

Finding Related Records

Many records may have associated related records (including permit amendments, time extensions, previously issued emergency permits, etc.). To find related records you may either look at your search result list to determine whether there is one or more related records to your record of interest by looking for a number in the column labeled **Related Records**. Click on the number in the Related Records column to see a list of related records, then select the **View** link from the results to see the related record you wish to review.
