(WITH THE POSSIBILITY OF EXTENSION OR BECOMING PERMANENT)

The California Coastal Commission (Commission) is a small State agency that is charged with protecting coastal resources and managing coastal development in California. The mission of the Commission is to implement the Coastal Act and to provide for the balanced use of the coastal zone and to protect, restore, and enhance coastal and marine resources for the continuing benefit of current and future generations. Employees at the Commission enjoy working on a broad range of issues to plan for and manage coastal land uses while protecting important coastal resources including wetlands, habitats that support rare and endangered species, scenic landscapes and views to the sea, public shoreline access and recreation opportunities. The Commission's staff includes dedicated planners, scientists, attorneys and administrative staff. A Commission limited-term position is a great opportunity to learn more about how a government agency functions and to obtain useful job experience for pursuit of a professional career in engineering or environmental and coastal management.

The Commission values diversity at all levels of the organization and is committed to fostering an environment in which employees from a variety of backgrounds, cultures, and personal experiences are welcomed and can thrive. We believe the diversity of our employees and their unique ideas inspire innovative solutions to further our mission of protecting and enhancing California's coast and ocean for present and future generations.

The Position: The Commission is seeking a motivated individual to work with the Technical Services Unit, more specifically with the Commission's Coastal Engineer and Staff Geologist, in matters of beach and bluff erosion, wave run-up and overtopping, armoring and options for living shorelines, sea level rise modeling and adaptation, and changes to shoreline dynamics from changing sea level conditions. This individual will become involved in a broad range of the Commission's regulatory and LCP planning work throughout the coastal zone. This position requires knowledge of engineering, earth systems, coastal processes, climate change science, wave forces and shoreline dynamics, strong verbal and written communication skills, and an ability to undertake independent analysis of engineering and geotechnical documents.

Desired Qualifications: The most important qualifications we seek are: an ability to extract and analyze information from a range of technical and engineering reports addressing a variety of coastal and ocean issues; independent and professional work habits; the ability to take direction and work with others; and, a commitment to quality work and attention to detail. Knowledge of engineering principles, earth systems, coastal processes, climate change and climate adaptation is required. Knowledge of the California Coastal Act, the Commission's permit and planning process, environmental terms and concepts is also highly desired. Persons with the following education and/or

work experience are preferred: civil/coastal engineering, coastal processes, earth science, geology, environmental science, or related fields.

The successful candidate will demonstrate strong analytic skills and the ability to research and interpret coastal resource issues. Strong writing and speaking skills and the ability to work as a team member are critical. Experience in environmental justice issues and/or tribal consultation experience are highly desirable attributes for all Commission employees. An advanced academic degree in a relevant field and computer and Matlab skills are highly desirable.

Eligibility: Individuals on the Engineer, Civil or Environmental Scientist eligible list may apply. Current state employees or former state employees with transfer or reinstatement rights at the Engineer, Civil or Environmental Scientist level may also apply. (Please note that in order to be eligible to transfer or reinstatement, applicants **must** meet the minimum qualifications of the Engineer, Civil or Environmental Scientist classification.) Appointment is subject to the State Restrictions of Appointment (SROA) provisions. Applicants must clearly indicate the basis of their eligibility, including SROA, surplus, transfer, re-employment status, or list eligibility in the Examination or Title section on the CA State Application (STD 678).

Individuals interested in this position who are not currently on an eligible civil service list may either take the Environmental Scientist examination online or apply for the Engineer, Civil examination. The Commission will conditionally accept applications from applicants who meet the minimum qualifications for the Engineer, Civil or Environmental Scientist classification but who are not on an eligible list, subject to successful completion of the appropriate examination (see below).
