PROJECT DESCRIPTION

The proposed project consists of completing a multi-element update of the Mendocino County Local Coastal Program (LCP) and associated technical studies. The overall goal of the project is to improve local coastal planning in Mendocino County to better address coastal resiliency and climate change adaptation by updating technical studies, descriptions, policies, maps, and the implementation plan for the LCP in order to adapt to the impacts of climate change, sea level rise, and associated coastal hazards while maintaining the overall quality of the coastal zone environment in the interest of all people. The Land Use Plan was effectively certified on November 20, 1985. The zoning and implementation plan portion of the LCP was certified with suggested modifications on March 15, 1991. The Mendocino County Board of Supervisors adopted these suggested modifications on July 22, 1991. The Commission effectively certified the total LCP on September 10, 1992, and the County assumed permit-issuing authority on October 13, 1992. A Categorical Exclusion Order (E-91-2) was approved by the Commission on June 10, 1992, and an Amendment to the Categorical Exclusion Order (E-94-2-A) was approved with conditions on January 11, 1995. The LCP was most recently revised in October 2017 for the Town of Mendocino segment and in 2021 with the establishment of regulations for Accessory Dwelling Units and Junior Accessory Dwelling Units. As such, it is critical that the LCP be updated to reflect the significant physical and regulatory changes that have occurred in the last few decades, including adaptation to climate change and effectively regulating coastal development.

The primary objectives of this LCP update are to develop an understanding of the existing conditions and evaluate current water/sewer capacity, circulation/transportation, agricultural resources, coastal access/visitor serving facilities, rare plant/natural communities, and visual resources and recommend updated goals, policies and objectives based on the evaluations. The LCP update will additionally integrate relevant information from the proposed *Mendocino County Sea Level Rise Resiliency Analysis* currently under consideration for Coastal Commission Non-Competitive LCP funding and National Fish and Wildlife Foundation Coastal Resilience Program funding. The proposed *Sea Level Rise Resiliency Analysis* will significantly improve understanding of anticipated localized impacts of sea level rise, and the data and results will be integrated into updated goals, policies, and recommendations. Additionally, the County will consider public benefits of the coast and disparities of environmental harms and services in marginalized communities while updating the LCP.

A primary focus of this LCP update will be to address impacts of climate change and integrate goals, policies, and recommendations to allow the coast of Mendocino County to better mitigate climate change and adapt to its impacts. The update will allow updated sections to integrate relevant information from the proposed *Sea Level Rise Resiliency Analysis*. This will also allow other studies in the LCP to be updated to reflect how climate change has already begun to impact the area. It is important to address these changes as climate change has already impacted the availability of domestic water supplies, agricultural resources, open space, and forests. Impacts

of climate change will also potentially be increased by results of future growth, such as increased greenhouse gas emissions resulting from increased traffic and use of recreational facilities, if not appropriately addressed. Therefore, the LCP update would yield an improved understanding of the impacts of future growth on climate change. Furthermore, certain resources, such as agricultural resources, forests, open space, and alternative energy sources, can be used to mitigate climate change by decreasing greenhouse gas emissions and increasing carbon sequestration. The LCP update would allow a better understanding of how to utilize these resources to mitigate climate change and update standards in the LCP to increase and accelerate beneficial adaptation approaches.

The proposed funding award will allow the County to complete updates to its LCP, including but not limited to the following: updating the background and policies in various section, updating studies referenced in the LCP, updating land use maps, completing environmental review consistent with the California Environmental Quality Act, incorporating comments from the California Coastal Commission and public, and updating the Coastal Zoning Code.

While in-kind contributions are not a requirement for this grant, the County will provide approximately 1,784 hours of staff time to assist the consultant team with public outreach, engagement, and meetings, stakeholder planning, and leading the efforts to update the Coastal Zoning Code.

1. Mendocino County Climate Action Advisory Committee (MCCAAC)

The MCCAAC was formed in July 2019 by Board of Supervisors Resolution No. 19-207. Membership consists of fifteen (15) members appointed by the Board of Supervisors for a term of three (3) calendar years. The MCCAAC will be consulted during the LCP update process, with a focus on understanding and coordinating goals and policy positions between the LCP and the MCCAAC.

Information gathering and SLR assessments are anticipated to be completed in November 2023, allowing data from the SLR Resilience Strategy project to be integrated into relevant portions of the proposed LCP update.

As part of an update to the County's General Plan Safety Element, the County completed an overall Climate Change Vulnerability Assessment in March 2021. Relevant information from this assessment will be integrated into the proposed LCP update.

RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AUTHORIZING FILING OF AN APPLICATION FOR A MULTI-ELEMENT UPDATE OF THE LOCAL COASTAL PROGRAM TO THE CALIFORNIA COASTAL COMMISSION LCP COMPETITIVE LOCAL ASSISTANCE GRANT PROGRAM, IN THE AMOUNT OF \$2,177,399, AUTHORIZING THE CHIEF EXECUTIVE OFFICER TO EXECUTE THE GRANT AGREEMENT AND SUBMIT ALL DOCUMENTS IF AWARDED

WHEREAS, the Budget Act of 2021 provides up to \$31 million to support the Coastal Commission's LCP Local Assistance Grant Program which awards grants to local governments to support coastal resiliency and updates to Local Coastal Programs (LCPs); and

WHEREAS, the California Coastal Commission, under the authority of the California Coastal Act, may provide financial assistance to support coastal planning and has approved a grant program to provide such financial assistance for LCP planning; and

WHEREAS, the goal of the grant program is to develop new or updated LCPs in conformance with the California Coastal Act and to promote coastal resiliency and address the effects of climate change; and

WHEREAS, grant proposals submitted under this grant program must complete Local Coastal Program (LCP) planning work with special emphasis on coastal resiliency and addressing the effects of climate change and sea-level rise; and

WHEREAS, the County of Mendocino, has an effectively certified LCP; and

WHEREAS, the County of Mendocino, desires to pursue a project that would result in the completion and submittal for certification by the California Coastal Commission of an Amendment to the LCP in part; and

WHEREAS, the County of Mendocino commits to and agrees to fully support a planning effort intended to amend a certified LCP pursuant to the provisions of the California Coastal Act, with full public participation and coordination with the Coastal Commission staff.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors of the County of Mendocino, hereby:

- 1. Directs County of Mendocino staff to submit the grant application package attached hereto as Attachment 1 to the California Coastal Commission to provide financial and planning assistance, under authority of the California Coastal Act, in the amount of \$ 2,177,399 to fund the project more particularly described in the grant application package.
- 2. Authorizes the Chief Executive Officer of the County of Mendocino to execute, in the name of the County of Mendocino, all necessary applications, contracts and agreements and amendments thereto to implement and carry out the grant application package attached hereto and any project approved through approval of the grant application.
