Molly Munz - Coastal Marinas Permit and State Board Acitvities

- 2. The State Board is working with stakholders to conduct studies by funding a 319h grant of 600 thoushand dollars to Shelter Island Marian in San Diego for financial incentives to repaint boats with non-copper based paints.
- 3. The State Board sent a letter to Assemblyman Silva in response to his request for additional information.

Vivian Matuk - Flares

Only 13 out of 58 Household hazardous wastes centers collect marina flares. There is a working subcommittee composed of Vivian of the California Coastal Commission (CCC) and Department of Boating and Waterways (DBW), DTSC, CalRecycle and the CCC.

Vivian calculated the estimated number of expired flares generated along the coast of California in one year, **174**, **026**. The group wants to find the best solution for the whole state.

Producer responsibility may be the best solution. Statewide legislation for producer responsiability did not go through legislation. Individual products are resulting in product repsonsability like batteries.

The California Product Stewardship Council works on producer responsibility and a next step is to contact this group.

Education is the next step in getting flares disposed of properly. The DBW can conduct a mass mailing, use the Dockwalker program, and harbormasters to get information to boaters.

Mara Noelle - Plastics

AB 1998 is a plastic bag eliminates the distribution of plastic bags in California and encourage the use of paper bags made with recycled paper. It will be heard again on August 13th by the Senate Appropirations Committee.

Molly Munz states there is a Marine Debris Working Group. It is a non-enforcement function that studies resources of nerdles P-3 pelletes. These pellats are not regulated by undustry. Pellets are coming from transportation, fropping from trains in transit.

The end products made from the pellets can be regulated through a stormwater permit, trash can be par of an MS4 permit.

Jenny Newman – In the LA region, the Regional Board has a trash TMDL in Santa Monica Bay for harbors.

Barbara Heinsch - Doc Powell is working with CalRecycle on removing abandoned commercial vessels between Bradford Island and Webb Track.

Nan Singhasemanon – The reevaluation of copper paint has be publicly noticed by the Dept. of Pesticide Regulation

He will be reporting on the recent risk management decision by the EPA on microbial uses of copper in the Antifouling portion of the meeting.
