

EXECUTIVE DIRECTOR'S DETERMINATION AND REPORT FOR COMMISSION REVIEW AT THE MEETING OF FEBRUARY 9, 1996

Background

Amendment # 3-95 was certified by the Commission on November 15, 1995. On December 12, 1995, the Board of Supervisors considered the Commission's action and acknowledged receipt of the resolution of certification from the Commission.

As provided for in Section 13544 of the Commission's Administrative Regulations, the Executive Director must determine that the action of San Luis Obispo County is legally adequate and report that determination to the Commission.

Recommendation

It is recommended that the Commission concur with the determination of the Executive Director that the action of the Board of Supervisors of San Luis Obispo County accepting the certification of LCP Amendment #3-95 is legally adequate.
