APPLICANT: City of Santa Barbara (Waterfront Facilities)

PROJECT DESCRIPTION: Miscellaneous modifications to existing structures on Stearns Wharf: ADA access ramps, protective structures for 2 doorways, new ticket kiosk, exterior staircases at Stearns Wharf, and exterior staircase for Ice Machine on Navy Pier

PROJECT LOCATION: Stearns Wharf and Navy Pier, Santa Barbara Harbor, City of Santa Barbara

Code Sections 13150(b) and 13158, you must sign the enclosed duplicate copy acknowledging the permit's receipt and accepting its contents, including all conditions, and return it to our office. Following the Commission's meeting, and once we have received the signed acknowledgement and evidence of compliance with all special conditions, we will send you a Notice of Administrative Permit Effectiveness.

BEFORE YOU CAN OBTAIN ANY LOCAL PERMITS AND PROCEED WITH DEVELOPMENT, YOU MUST HAVE RECEIVED BOTH YOUR ADMINISTRATIVE PERMIT AND THE NOTICE OF PERMIT EFFECTIVENESS FROM THIS OFFICE.

STANDARD CONDITIONS:

1. Notice of Receipt and Acknowledgment. The permit is not valid and development shall not commence until a copy of the permit, signed by the permittee or authorized agent, acknowledging receipt of the permit and acceptance of the terms and conditions, is returned to the Commission office.
2. Expiration. If development has not commenced, the permit will expire two years from the date this permit is reported to the Commission. Development shall be pursued in a diligent manner and completed in a reasonable period of time. Application for extension of the permit must be made prior to the expiration date.
3. Compliance. All development must occur in strict compliance with the proposal as set forth in the application for permit, subject to any special conditions set forth below. Any deviation from the approved plans must be reviewed and approved by the staff and may require Commission approval.
4. Interpretation. Any questions of intent or interpretation of any condition will be resolved by the Executive Director or the Commission.
5. Inspections. The Commission staff shall be allowed to inspect the site and the project during its development, subject to 24-hour advance notice.
6. Assignment. The permit may be assigned to any qualified person, provided assignee files with the Commission an affidavit accepting all terms and conditions of the permit.
7. Terms and Conditions Run with the Land. These terms and conditions shall be perpetual, and it is the intention of the Commission and the permittee to bind all future owners and possessors of the subject property to the terms and conditions.

EXECUTIVE DIRECTOR'S DETERMINATION (continued):

The Executive Director hereby determines that the proposed development is a category of development which, pursuant to PRC Section 30624, qualifies for approval by the Executive Director through the issuance of an administrative permit. Subject to Standard and Special Conditions as attached, said development is in conformity with the provisions of Chapter 3 of the Coastal Act of 1976, will not prejudice the ability of the local government to prepare a Local Coastal Program that is in conformity with the provisions of Chapter 3, and will not have any significant impacts on the environment within the meaning of the California Environmental Quality Act. If located between the nearest public road and the sea, this development is in conformity with the public access and public recreation policies of Chapter 3.

FINDINGS FOR EXECUTIVE DIRECTOR'S DETERMINATION:

The project consists of a number of minor modifications to existing structures on Stearns Wharf and the Navy Pier in Santa Barbara Harbor. These consists of a new ticket kiosk of approximately 50 square feet near the passenger loading ramp (229 Stearns Wharf); a stairway at the ice house to the Naval Pier; a stairway to the second floor of the Shellfish Building (230 Stearns Wharf); weather proofing of doors for two buildings (219c and 219f Stearns Wharf); and ramping and modifications to disabled access to two buildings (217 and 219 Stearns Wharf).

All of the proposed modifications will be to existing structures, and will not expand or alter any existing uses. (Exhibits 1 and 2)

The Executive Director therefore finds that the proposed project is consistent with all applicable Coastal Act policies.

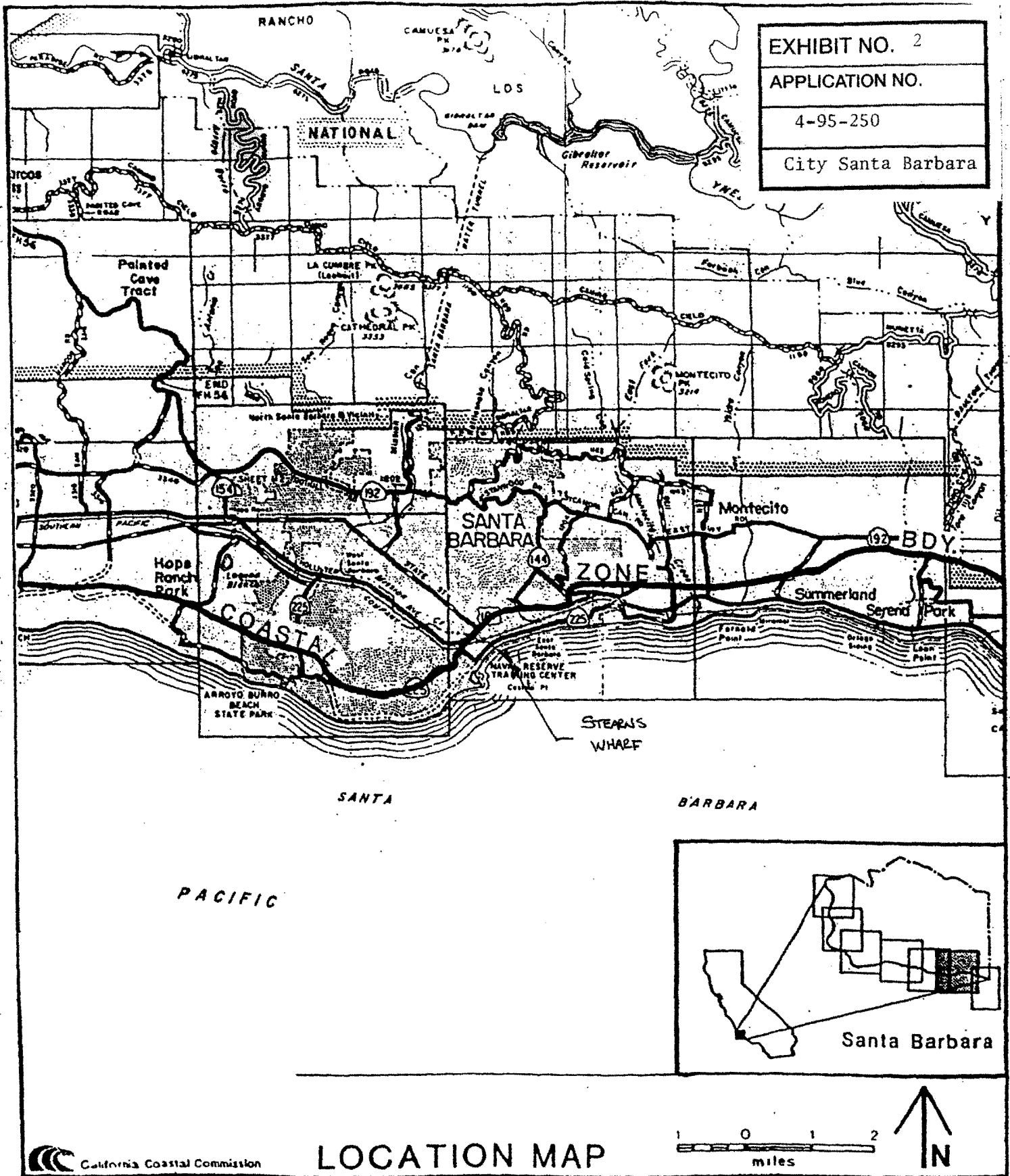

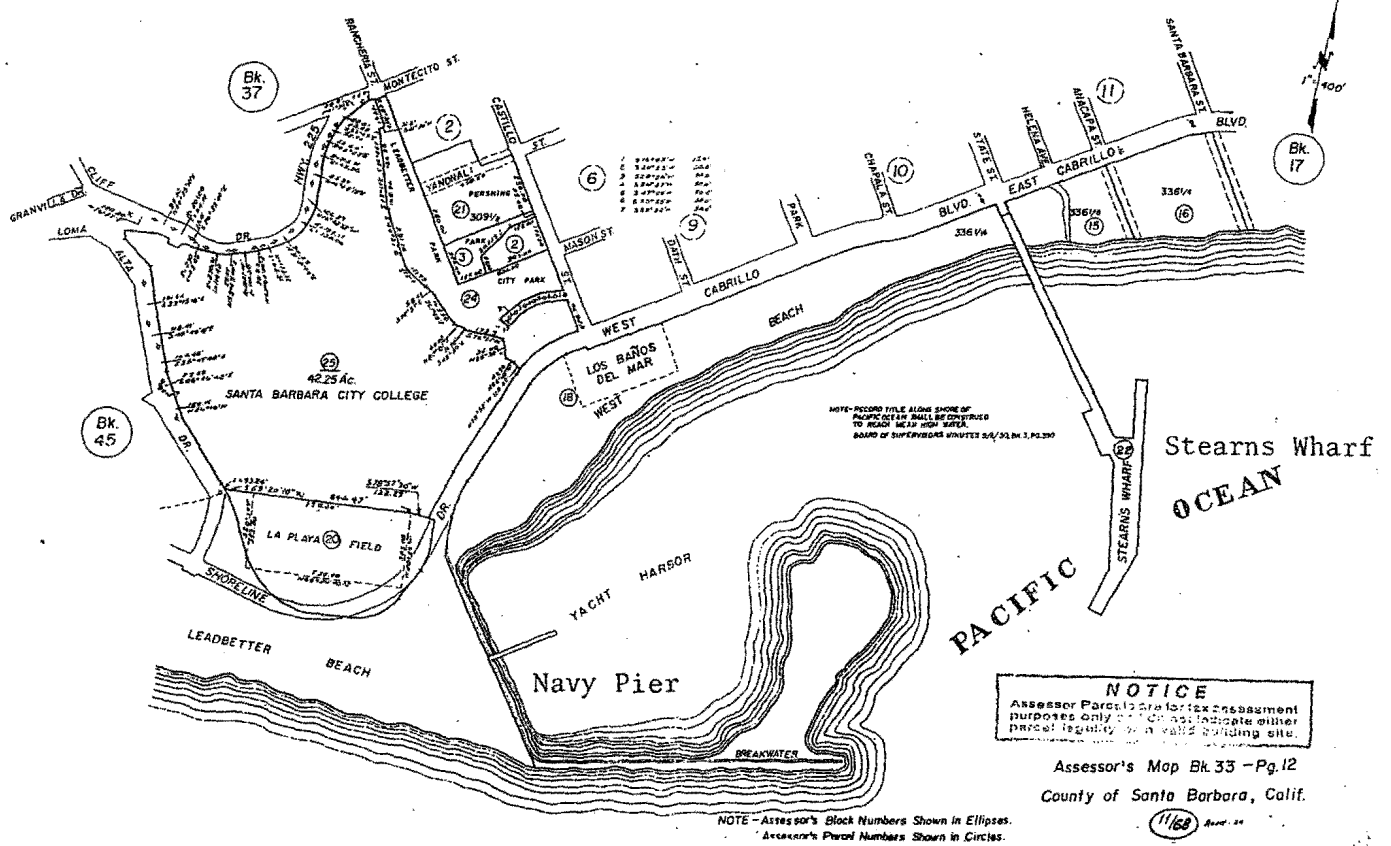
