SUBJECT: EFFECTIVE CERTIFICATION OF PORT OF SAN DIEGO MASTER PLAN  
AMENDMENT NO. 19/National City Marina (for Commission review at  
its meeting of April 9-12, 1996)

BACKGROUND

At the Commission meeting of August 11, 1994, the Commission reviewed and approved Amendment #19 to the certified Port of San Diego Master Plan pertaining to the National City Marina. The proposed amendment was approved as submitted. Revised findings were adopted by the Commission at the November 3, 1994 meeting.

By their action on March 26, 1996, the Board of Port Commissioners has concurred and accepted the Commission's certification of the master plan amendment, as submitted. The Board has therefore adopted the master plan amendment as certified by the Commission.

As provided for in Section 13623(e) of the Commission's Code of Regulations, certification of the master plan amendment is not final and effective until the port governing body takes formal action adopting the amendment as certified by the Commission and the Commission has accepted the formal action. The Board's action has been reviewed and determined to be adequate by the Executive Director. To finalize Commission review of this port master plan amendment, the Commission must accept the port governing body's action. The attached letter would be sent to the Port of San Diego after Commission endorsement.

RECOMMENDATION

Staff recommends that the Commission ACCEPT the Board of Port Commissioners' formal action adopting the port master plan as being consistent with the Commission's certification.
