CITY OF HALF MOON BAY LCP CERTIFICATION

REVIEW: Concurrence with the Executive Director's determination that the action of the City of Half Moon Bay accepting the Commission's certification of the City's Local Coastal Program (LCP) Implementation Program with suggested modifications is legally adequate. (For Commission review at the meeting of April 10, 1996 in Carmel.)

BACKGROUND

The Land Use Plan (LUP) portion of the City of Half Moon Bay's Local Coastal Program (LCP) was certified by the Coastal Commission in September 1985. The City's submittal of the Implementation Program, which is necessary to complete the LCP, was filed on October 19, 1995. The Implementation Program, which applies to the entire City as the entire City is within the coastal zone, consists of revisions to the City's Zoning Code, Zoning Map, and Subdivision Code. On December 13, 1995, the Coastal Commission approved the Implementation Program with eighteen suggested modifications. Under Section 13542(b) of the California Code of Regulations, the Commission's certification is valid for six months, or through June 13, 1996.

EFFECTIVE CERTIFICATION

On January 16, 1996, the City Council of the City of Half Moon Bay adopted Resolution No. C-5-96 (attached Exhibit 1), whereby the City:

accepts and agrees to the Suggested Modifications adopted by Resolution (December 1995) of the Coastal Commission; agrees to take whatever formal action is necessary to implement the suggested modifications; and agrees to issue Coastal Development Permits for projects found to be in conformance with the Local Coastal Program.

Subsequent to the Council's adoption of Resolution No. C-5-96, and following local public hearings, the City's Planning Commission made the changes to the Implementation Program that reflect and encompass all of the Commission's eighteen suggested modifications. On March 19, 1996, the City Council ratified these changes, by formally adopting amendments to City ordinances, thus accomplishing the suggested modifications.

As provided in Section 13544 of the California Code of Regulations, the Executive Director must determine if the action of the City, in response to the Commission's December 1995 certification with suggested modifications, is legally adequate to finalize Commission review of the LCP. The Executive Director has reviewed the City's action and has determined it to be legally adequate.

Regulations Section 13544 further requires this determination to be reported to the Commission for Commission concurrence. The LCP is deemed certified if the Commission concurs with the Executive Director's determination.

The City will assume coastal development permit authority as soon as the LCP is "effectively certified." This "effective certification" will take place when the Secretary for Resources, pursuant to Public Resources Code Section 21080.5(d)(2)(V), files the Commission's Notice of Determination that the Commission has certified the LCP. Normally the Secretary for Resources files the Notice of Determination three weeks to one month from the date the Commission certifies the LCP. Therefore, if the Commission certifies the Half Moon Bay LCP at the April 10-12, 1996 meeting, the LCP likely will be effectively certified by mid May, 1996.

STAFF RECOMMENDATION

The staff recommends that the Commission concur with the determination of the Executive Director that the action of the City of Half Moon Bay accepting the Commission's certification of the LCP with suggested modifications is legally adequate.

WHEREAS, as a part of the L.C.P. Zoning Implementation process, it became necessary to revise and update the City Zoning Code and the Zoning Map to ensure consistency and conformity with the Land Use Plan Map; and

WHEREAS, after a public hearing the City Council directed Staff to forward the Implementing Ordinances and Zoning Map to the Coastal Commission for Certification; and

WHEREAS, at its meeting of December 13, 1995, the Coastal Commission unanimously approved the Implementing Ordinances with Suggested Modifications; and

WHEREAS, the Half Moon Bay City Council considered the actin of the Coastal Commission at its meeting of January 16, 1996; and

WHEREAS, all those in attendance desiring to be heard at the City Council public hearings were given an opportunity to speak; and
