Dear Mr. Muslin:

The Coastal Commission staff has received the above-referenced negative determination for the maintenance dredging of approximately 60,000 cu. yds., as well as some minor pier repair work, at the Navy's Fleet and Industrial Supply Center, near Ballast Point in Point Loma. Disposal would be at the EPA approved offshore disposal site LA-5. The dredging is needed to maintain safe navigational depths for Navy fueling operations.

The Navy has tested the dredge spoils against the "Green Book" standards, and the test results have been reviewed by the Commission staff and at least preliminarily reviewed by EPA. The test results indicate the dredge materials are not contaminated, and, therefore, are suitable for disposal at LA-5. The grain size analysis shows the dredge spoils are not predominantly sand and, therefore, are not appropriate for beach replenishment. The dredging has been scheduled to occur outside the April 15 to September 1 period when it could affect least terns; therefore habitat effects from dredging have been minimized.

We agree with your assessment that the resources of the coastal zone will not be adversely affected by the project. We therefore <u>concur</u> with your negative determination made pursuant to Section 15 CFR 930.35(d) of the NOAA implementing regulations. Dear Mr. Curtis:

The Coastal Commission staff has reviewed your negative determination for proposed repairs to the Marine Mammal Pier located at the Navy's Magnetic Silencing Facility on San Diego Bay. The project consists of constructing a 70 square-foot wooden deck addition to the pier in order to provide a safe deck area on the pier for handling and transporting marine mammals from the pier into and out of small boats. No new pilings or any in-water construction are required as the proposed deck addition will be supported by and attached to the existing pier. Approximately 0.002 acres of San Diego Bay water area would be shaded by the proposed deck addition. Any marine resource impacts associated with this structure would be minor in nature and mitigated by using 0.002 acres of the Navy's existing 0.3 acres of mitigation credit remaining from the prior removal of the Naval Training Station pier on San Diego Bay.

In conclusion, the proposed deck addition will not adversely affect any resources of the coastal zone. We therefore concur with your negative determination made pursuant to 15 CFR 930.35(d) of the NOAA implementing regulations. Dear Mr. Setnicka:

The Commission staff has received the above-referenced negative determination from the National Park Service (NPS) for the construction of a new ranger station and housing facility near the southwest corner of the airstrip at Cuyler Harbor on San Miguel Island, one of five islands comprising Channel Islands National Park. San Miguel Island is owned by the U.S. Navy and jointly administered by the NPS and the Navy. After a joint NPS/Navy multiyear planning effort, the NPS proposes to construct a 2,300 square-foot structure consisting of two one-bedroom apartments, a four-person bunkhouse, a multi-purpose office area, and various utility rooms. Electrical power would be supplied by a combination of solar and wind generation, propane would be used for cooking and space heating, and water would be obtained from the existing well in Nidever Canyon, rain catchment on the roof of the new structure, and fog collection curtains. A leach field augmented by infiltrator plastic chambers would be used for disposal of grey water and sewage. In addition, the existing substandard ranger station and housing facilities in Nidever Canyon will be removed and this sensitive habitat area restored.

The proposal is consistent with the 1985 General Management Plan for Channel Islands National Park which calls for "...a permanent residence for the island ranger in the Lester Ranch area near Cuyler Harbor." The NPS states in its Environmental Assessment for the project that the proposed structure is necessary because the existing facility is comprised of two deteriorating 8' x 20' shipping containers, which the NPS has identified as sub-standard housing for its personnel. In addition, the containers and the existing grey water disposal system are located in Nidever Canyon, an area zoned by the NPS as a Protected Natural Area. Finally, the method of transportation of NPS personnel from the mainland to San Miguel Island has shifted over the years from Navy helicopters to commercial airplanes. The existing station is close to the helipad but is one-half mile from the Cuyler Harbor airstrip, and for logistical reasons the NPS believes it is necessary to locate the ranger

station at Cuyler Harbor, the only place on the island where private and excursion boats can land (there is no public air service to the island).

The project will generate only minor and temporary effects on coastal resources. The NPS states that construction and use of the new facility will not adversely affect any sensitive plant or animal species. No Chumash archeological sites or cultural resources are documented in the vicinity of any of the building sites. While the new facility will slightly affect views of the island landscape from Cabrillo Monument and Lester Ranch, visitors to the island will be better served by the new and more easily accessible ranger station. In addition, removal of substandard and deteriorating facilities in Nidever Canyon and the restoration of that site will yield net environmental benefits for the island.

In conclusion, the proposed construction of a new ranger station and housing facility at the Cuyler Harbor airstrip and the removal of the existing facility in Nidever Canyon will not significantly affect the coastal zone. The project will improve the ability of the NPS to protect natural resources and provide visitor services on the island. We therefore concur with your negative determination made pursuant to Section 15 CFR 930.35(d) of the NOAA implementing regulations. The Coastal Commission staff has received your request to identify Commission jurisdiction for the purposes of processing an individual, nationwide, general or regional permit from the Army Corps of Engineers (Corps). Pursuant to the federal Coastal Zone Management Act (CZMA), the Corps cannot issue a permit for an activity, either in or out of the coastal zone, that affects land and water uses or natural resources of the coastal zone until the applicant has complied with the requirements of Section 307(c)(3)(A) of the CZMA. (16 USC Section 1456[c][3][A].) The applicant can meet these requirements by receiving a Commission concurrence with either (1) a consistency certification prepared by the applicant or (2) a showing that the activity does not affect the coastal zone. Alternatively, the applicant can satisfy these requirements by the issuance of a Commission approved coastal development permit. Since the Commission cannot delegate federal consistency authority to local governments, a coastal development permit issued by a local agency does not replace the requirement for a consistency certification. However, if an activity is within the Ports of San Diego, Long Beach, Los Angeles, or Port Hueneme and is identified in the Commission certified Port Master Plan, then no consistency certification is necessary.

The Coastal Commission staff has reviewed the information submitted for the above-referenced project, and has concluded that it:

Is not within the coastal zone and does not affect the coastal zone. Therefore no further Coastal Commission review is necessary,

Is a non-federal activity within the coastal zone and is in an area where the Commission has not delegated permit authority to the appropriate local agency. Therefore, it needs a coastal development permit from the Commission. Contact our South Coast Area Office (see addresses





on the following page) for details and permit application form. (Note: Receipt of a Coastal Commission-issued coastal development permit satisfies federal consistency requirements.)

Is a federally permitted activity within or affecting the coastal zone and does not otherwise need a coastal development permit from the Commission. Therefore, this project needs a consistency certification. Contact <u>Jim Raives at (415) 904-5292</u> for information on the federal consistency process. (Note: Receipt of a local government-issued coastal development permit, as opposed to a Coastal Commission-issued coastal development permit, does not satisfy federal consistency requirements.)

Is within or affects the coastal zone and is a federal agency activity. Therefore it needs a consistency determination (or, at a minimum, a negative determination). Contact Jim Raives at (415) 904-5292 for information on the federal consistency process.

Is within the port of San Diego, Long Beach, Los Angeles, or Port Hueneme and is consistent with a certified Port Master Plan. Therefore, no further Coastal Commission review is necessary.

Is within one of the above ports but is not consistent with a certified Port Master Plan. Therefore, a Port Master Plan amendment is necessary.

We have insufficient information on the project location or details to determine jurisdiction. Please provide the following information:

The Coastal Commission declines to assert federal consistency jurisdiction, due to the fact that: (1) this project has or will receive a locally issued coastal development permit and is located within an area where such permits are appealable to the Coastal Commission; and (2) the proposed project does not significantly affect coastal resources or raise coastal issues of greater than local concern.
