

SUBJECT: MENDOCINO COUNTY LCP AMENDMENT NO. 1-96 (MAJOR: Site A, Flanagan) CERTIFICATION REVIEW: Concurrence with the Executive Director's determination that the action of Mendocino County accepting the Commission's certification of Mendocino County Amendment No. 1-96 (Major): Site A is legally adequate. (For Commission review of the meeting of March 13, 1997 in Carmel.)

A. BACKGROUND:

In May of 1996, the County of Mendocino submitted to the Commission an LCP amendment request consisting of two parts. Because the submittal for Site A (Flanagan) was complete, while the submittal for Site B (Mendocino Coast Properties) was not complete, Commission staff separated the submittal into two parts: (1) Mendocino County LCP Amendment No. 1-96 (Major): Site A, Flanagan, which is the subject of this certification review, and (2) Mendocino County LCP Amendment No. 1-96 (Major): Site B, Mendocino Coast Properties, which will be considered separately by the Commission once the County submittal is complete.

B. AMENDMENT DESCRIPTION:

The changes approved by Amendment No. 1-96, Site A, are as follows:

1. <u>SITE A (GP 13-95/R 15-95, FLANAGAN)</u>. APN 144-012-07. Change the Coastal Plan land use designation of a .86-acre parcel from Rural Residential-5 acre minimum [Rural Residential-2 acre minimum] *4 (RR-5[RR-2] *4) to Rural Residential-5 acre minimum [Rural Residential-2 acre minimum] *1C (RR-5[RR-2] *1C) with a note placed on the LUP and Zoning maps associated with the *1C which establishes a cap of 6 visitor-serving units on this site, and to rezone the parcel from RR:L-5[RR:L-2] *4 to RR:L-5[RR:L-2] *1C. The *4 will be deleted from the LUP and Zoning maps. The site is located at 34591 South Highway One, adjacent to the north side of Highway One at its intersection with Fish Rock Road, approximately a half-mile northwest of Anchor Bay.

The Commission completed its action on Mendocino County LCP Amendment No. 1-96 (Major): Site A at its July 10, 1996 public hearing. The Commissioners voted unanimously to certify LCP Amendment No. 1-96 (Site A) as submitted.

B. Effective Certification.

The County has acknowledged receipt of the Commission's resolution of certification of the LCP Amendment as shown in the Board of Supervisors' Resolution No. 96-179 and Ordinance No. 3951 (see Attachment B), adopted by the Mendocino County Board of Supervisors on September 23, 1996.

As provided in Sections 13544 and 13544.5 of the Commission's Code of Regulations, for the amendment to become effective, the Executive Director must determine that Mendocino County's action is legally adequate and report that determination to the Commission. Unless the Commission objects to the determination, the certification of Mendocino County LCP Amendment No. 1-96 (Major): Site A shall become effective upon the filing of a notice of certification for the LCP Amendment with the Secretary for Resources, as provided in the Public Resources Code Section 21080.5(d)(2)(V).

STAFF RECOMMENDATION:

Staff recommends that the Commission concur with the determination of the Executive Director that the action of the County of Mendocino accepting the Commission's certification of the Mendocino County LCP Amendment No. 1-96 (Major): Site A is legally adequate, as noted in the attached letter, Attachment A (to be sent after Commission concurrence).

NOW, THEREFORE, BE IT RESOLVED, that the Mendocino County Board of Supervisors hereby amends the Land Use map of the Coastal Element of the Mendocino County General Plan as follows and as illustrated in Exhibit A, showing the affected portion of the Land Use map as amended:

 Amend the Coastal Element Land Use Map Number _____ as shown on Exhibit "A" for GP 13-95 changing the land use classification on Assessor's Parcel Number 144-012-07 from RR-5[RR-2]*4 to RR-5[RR-2]*1C, stipulating that a note be placed on the Land Use Map establishing a cap of 6 visitor serving units on this site.






Exhibit A R 15-95
