SUBJECT: Commission meeting of May 13-16, 1997, Request to extend the 90 day time limit for Commission action on Laguna Beach LCP amendment 2-96 which affects both the land use plan and implementation plan portions of the Local Coastal Program.

On December 31, 1996 the South Coast District staff received LCP amendment request 2-96 from the City of Laguna Beach. The submittal was deemed incomplete. On March 21, 1997 additional information was received and the amendment submittal was deemed complete, pursuant to the requirements of Section 30510(b) of the Coastal Act.

Pursuant to Section 30512 of the Coastal Act, an LCP amendment affecting the land use plan and implementation plan portions of the LCP must be acted on by the Commission within 90 days of complete submittal. In order to be heard within the allotted time period, the amendment would have to be scheduled for Commission hearing at the current, May 13-16, 1997 hearing. Section 30517 of the Coastal Act allows the Commission to extend, for good cause, the 90 day time limit for a period not to exceed one year.

Commission staff is requesting this extension to allow additional time to review the amendment request. The City of Laguna Beach has been consulted and does not object to the extension request.

Staff Recommendation: Staff recommends that the Commission extend the 90 day time limit for a period not to exceed one year. However, it is anticipated that the amendment request will be scheduled for the August 12-15, 1997 Commission hearing in Los Angeles.
