### Amendment Description

On May 19, 1997 the Commission received an amendment transmitted by the County of Del Norte. On June 27, 1997 the Executive Director determined that the County's LCP amendment was in proper order and legally adequate to comply with the requirements of Section 30510(b) of the California Coastal Act.

As submitted, Del Norte County LCP Amendment No. 2-97 (Martin) would:

amend Del Norte County's implementation program to rezone the coastal zone portion of a 203-acre ranch parcel from A-5 (Agricultural General, 5 acres minimum lot size) and RCA-1 (General Resource Conservation Area) to A-5 and RCA-2(fw) (Designated Resource Conservation Area, farmed wetland). The subject property is located east of Highway 101 and east of Humboldt Road/Enderts Beach Road in Del Norte County.

Pursuant to Sections 30513 and 30514 of the California Coastal Act, LCP Amendment No. 2-97 (minor) must be scheduled for public hearing and the Commission must take action within 60 days after receipt of a complete transmittal. The 60th day after receipt of a complete transmittal is August 26, 1997. Therefore, the LCP Amendment would need to be scheduled for Commission review at or prior to the Commission's August 12-15, 1997 hearing.

On June 27, 1997 the Executive Director received a letter from Mr. Richard Martin, the property owner (attached). Mr. Martin requests that the public hearing on the RCA rezone of his property be scheduled to be heard in September in Eureka so that he can be present at the hearing. Granting an extension of time would allow for the requested local hearing.

Coastal Act Section 30517 states that the Commission may extend for good cause the 60-day time limit for a period not to exceed one year.

### Staff Recommendation

Staff recommends that the Commission vote to extend the deadline for Commission action for up to a year.
