At the October 2000 Coastal Commission meeting, the Commission asked the Executive Director to conduct public workshops at the November and December 2000 meetings regarding the inclusion of certain categories of U. S. Fish and Wildlife Service (USFWS) incidental take permits to the California Coastal Management Program (CCMP) as a "listed" activity subject to federal consistency review.

The Workshops and Commission Action

The goals of both workshops are to inform the Commission about the CCMP and habitat conservation/multi-species plans and to provide an opportunity for the Commission to hear from members of the public. Since this is a public workshop and hearing for the purposes described below, no action by the Commission is required on this item.

The *November* public workshop agenda was comprised of presentations from the Coastal Commission staff, the Director of the federal Office of Coast and Ocean Resources Management, staff from the USFWS, staff from the California Department of Fish and Game and a public comment period.

The focus of the *December* workshop is to provide an opportunity for discussion of a coordinated process for Coastal Commission involvement and interaction with the Department of Fish and Game in the preparation, approval and implementation of Natural Community Conservation Plans that affect coastal resources. The following agenda item topics that will likely be included on the *December workshop agenda* are:

- Proposed Memorandum of Understanding by and among Department of Fish and Game, Coastal Commission and the Resources Agency;
- Coastal Commission staffing and time commitments relating to participation in the NCCP/HCP processes; and
- Public comments.
