Background

Local Coastal Program Amendment # 1-99 was certified by the Commission on April 10, 2000, as submitted. On May 15, 2000, within the six month time limit for acting on and responding to the Commission's certification of an LCP amendment, the City Council considered the Commission's action and acknowledged receipt of the resolution of certification.

Recommendation
