The Commission finds and declares as follows:


A. <u>Port Master Plan Amendment Certification</u>. California Code of Regulations, Title 14, Section 13632(e) states that:

The certification of a port master plan [or amendment] shall not become effective until the port governing body takes formal action adopting such plan [amendment] as certified by the commission and the commission has received notice of such action, including the final EIR adopted for such action and the commission has accepted the formal action as consistent with its certification.

PMPA No. 16 April 16, 2001

On March 12, 2001, the Commission certified the Port of Long Beach's Port Master Plan Amendment No. 16. On March 19, 2001, the Board of Harbor Commissioners, of the Port of Long Beach, adopted the Commission's certification of plan Amendment No. 16. Acceptance of Coastal Commission Certification of Port Master Plan Amendment #16

Background

On February 15, 2001, the Board of Harbor Commissioners adopted Port Master Plan Amendment #16 for submission to the California Coastal Commission for certification as an amendment to the Port Master Plan. Port Master Plan Amendment #16 amends the certified Port Master Plan to allow the construction of a 45.4-acre landfill in Slip #1 of Pier E and a portion of the East Basin between Piers D, E, and F within the Middle Harbor Planning District (District #5). The Amendment would also allow use of approximately 22.7 acres (inner-harbor credits) of the available Bolsa Chica mitigation credits from the Landfill Mitigation Bank established by Port Master Plan Amendments #8 and #11. The environmental impacts of the proposed project were analyzed in the Piers D/E/F Terminal Redevelopment Project Final Environmental Impact Report, which the Board certified on January 22, 2001.

On March 12, 2001, the Coastal Commission certified the Port Master Plan Amendment #16. The Commission made findings that the Amendment conforms with Chapters 3 and 8 of the California Coastal Act. The Commission further found that the Amendment would not have any adverse impacts on the environment, consistent with the California Environmental Quality Act (CEQA).

Recommendation

Under the Coastal Commission's administrative regulations, the Board of Harbor Commissioners must take an action accepting the Coastal Commission's certification of the Amendment. We respectfully request that the Board accept the California Coastal Commission's certification of the Port Master Plan Amendment #16 and authorize the Executive Director to transmit notice of such acceptance to the Commission for its acknowledgement.
