1. **CALL TO ORDER.** The meeting of the California Coastal Commission was called to order on Monday, March 12, 2001, at 10 a.m. by Chairman Wan.
2. **ROLL CALL.** Present: Chairman Wan, Commissioners Dean, Desser, Dettloff, Estolano, Hart, McCoy, (Alternate) Orr, Neal, (Alternate) Rose and Woolley. Absent: Krueger and Sanders. McClain-Hill arrived at 11:20 a.m.; Sweeney arrived at 11:40 a.m.; and (Alternate) Weinstein arrived at 2:45 p.m.

3. **DEPUTY DIRECTOR'S REPORT.** Deputy Director Lee reported on matters not requiring public hearings, and on comments from the public. John Davis, representing Coalition to Save the Marina Sierra Club, submitted a request to speak. Sean Finnegan, representing Athens Group (Treasure Island), submitted a request to speak if necessary.

a. **Long Beach Port Plan Amendment No. 15 Certification Review.** Staff recommended approval.

Robert Kanter, representing Port of Long Beach, submitted a request to answer questions.

Motion & Vote: Woolley moved staff recommendation, seconded by Orr, and Chairman Wan ruled that the vote was unanimous. **Passed.**
