DISTRICT.

### I. LCP STATUS

Within the Commission's South Central Coast District, there are currently 10 local jurisdictions with 11 LCP segments. Nine of the segments (82 %) are effectively certified. All are overdue for Periodic Review.

# II. ONGOING LOCAL COASTAL PLANNING:

Several local governments are completing LCPs under planning grants awarded by the Commission:

• The County of Los Angeles is completing an LCP for the Santa Monica Mountains segment. The County has completed a Draft LUP, Policy Maps and Administrative Draft of the Implementation Program (LIP), Draft Public Access Strategic Plan and Draft Polluted Runoff Component.

- The City of Carpinteria is completing an update to portions of their LCP to develop a
  Creeks Preservation Program. Field studies, baseline condition reports and draft codes and
  policies reports have been prepared.
- The County of Santa Barbara is completing an update to portions of the LCP for the Ellwood Beach Area. Wetland, riparian and native grasslands resource maps have been completed.
- Preparation of the LCP for the **City of Malibu** is ongoing. The draft LUP policy plan is expected to be completed and released for public review in early September. Tentatively the Commission is scheduled to hold a public hearing on the draft LUP at its November hearing in the Los Angeles area; a second hearing (if necessary) would be held in January 2002, also in the Los Angeles area. The Implementation Plan for the Malibu LCP is scheduled for hearing by the Commission in the summer of 2002.

### III. OTHER RELATED PLANNING EFFORTS

South Central Coast District staff is working with local governments and various regional agencies in other major planning efforts, including:

- Working with the County of Ventura on LCP amendments intended to improve the coastal development permit process, and to resolve some inconsistencies in their LCP;
- Continued work with resource agencies, the County of Santa Barbara, University of California at Santa Barbara, other local governments and the U.S. Air Force on the best means to protect the Snowy Ployer; and
- Working to resolve issues related to greenhouse expansion on prime agricultural soils.

### III. POST-CERTIFICATION ACTIONS

In the South Central Coast District, most post-certification appeals of local coastal permit decisions have been made from decisions of the counties of Santa Barbara and Ventura. Of 89 appeals, the Commission found Substantial Issue in 22 of the appeals (25%). The issues raised most frequently have been Scenic and Visual Resources / Landform Alteration, Public Access and Hazards.
