### **CHAPTERED/VETOED LEGISLATION**

The following bills relating to the Coastal Act and/or coastal protection issues were signed or vetoed by the Governor at the end of the 2004 Legislative session.

#### **AB 800 (Kehoe) California Coastal Commission**

This bill makes technical, clean up amendments to the Coastal Act, eliminating the Secretary of Business, Transportation and Housing as an ex-officio member of the Commission, and other obsolete language.

#### **AB 1466 (Koretz) Litter**

This bill establishes a unified litter prevention and recycling message for the State of California, "Don't Trash California." The bill would authorize all relevant agencies to integrate the message into their existing litter and recycling programs. The bill authorizes the establishment of an interagency committee to collaborate on how to implement a unified litter prevention message. The Coastal Commission may participate on the Committee.

#### **AB 1876 (Chan) Beach Sanitation**

This bill extends existing public beach water quality testing and posting requirements to include beaches under the jurisdiction of BCDC, public bay beaches, if the beach is visited by at least 15,000 people per year, and is located adjacent to a creek mouth or storm drain outfall. This bill would also require that bilingual signs be posted in areas of bilingual use.

#### **AB 2093 (Nakano) Cruise ships: graywater**

This bill prohibits the release of graywater from cruise ships in state water, unless the vessel has met specified requirements to be developed by the State Water Resources Control Board.

#### **AB 2514 (NR Committee) Natural Resources, Environmental License Plate Fund**

This bill increases the fee for personalized license plates, including the Whale Tail plate, from \$25 to \$30, and authorize revenues in the Environmental License Plate Fund to be expended for the purposes enumerated in the California Ocean Protection Act of 2004, if that legislation should be enacted..

**AB 2529 (Kehoe) Marine Managed Areas**

This bill establishes a grant program within the State Water Resources Control Board, for the purpose of funding local public agencies and non-profit organizations to restore and protect water quality in marine managed areas. The bill requires the SWRCB to appoint a marine water quality task force to recommend projects.

**AB 2672 (Simitian) Large passenger vessels: sewage**

Existing law requires the State Water Resources Control Board to apply to the federal government to prohibit the release of specified substances in waters that are not in state waters, but are in certain marine sanctuaries. This bill requires the board to determine whether it is necessary for the state to apply to the federal government to authorize the state to prohibit the release of sewage, as defined, from large passenger vessels into the marine waters of the state. If the board determines that it is necessary, the bill would require the board to make that application. The bill would authorize the Legislature to request the US Congress to grant authority to the State to regulate the discharge of sewage into marine waters of the state. The bill requires the owner or operator of a large passenger vessel that releases sewage into the marine waters of the state or a marine sanctuary, as defined, to immediately report the release to the board, as specified, and impose civil penalties..

**AB 2702 (Steinberg) Housing: second units**

This bill further limits local governments' discretion over the mandate to allow the construction ministerially approved second units. This bill would prohibit local governments from establishing a minimum unit size requirements for second units or from requiring covered parking for second units, more than one parking space per bedroom, or that occupants of a second unit must be owners, family members or care givers, of property owner, among other restrictions. The bill specifies that none of its provisions shall be construed to lessen the effect or application of the Coastal Act.

**AB 2722 (Laird) Natural Heritage Tax Credit**

This bill allows bond funds to fund the Natural Heritage Tax Credit program, which is currently suspended. This would, in effect, allow the use of bond funds to reimburse the General Fund for tax credits extended to sellers of conservation acquisitions. This bill also allows local governments and non-profits to apply for the Tax Credit Program directly.

**AB 2918 (Laird) Desalination facilities: electricity rates**

This bill directs the Public Utilities Commission to prepare a report to the Legislature, on or before January 1, 2006, examining the interrelationship between energy policies and water policies as they relate to desalination. The Commission is one of several state agencies that would be invited to participate in the study.

Status Filed with Secretary of State, Chapter 648, Statutes of 2004

**SB 18 (Burton) Sacred Sites**

This bill allows federally recognized Indian Tribes and tribes recognized by the Native American Heritage Commission to acquire and hold conservation easements. This bill would require the Office of Planning and Research to prepare guidelines for contacting and consulting with Native American tribes when a local government in preparing an amendment to a mandatory element of a General Plan, for the purpose of protecting cultural sites, and allow local open space plans to protect open space for the purpose of preserving Native American cultural resources.

**SB 318 (Alpert) Desalinated Water**

This bill requires that Urban Water Management Plans, prepared by urban water suppliers and submitted to the Department of Water Resources, must include a description of the opportunities for providing water via desalination.

**SB 792 (Sher) Martini Creek Bypass**

This bill authorizes CalTrans to declare as excess property and transfer to the Department of Recreation approximately 300 acres of land within McNee State Park. This transfer will effectively allow the construction of the Devil's Slide tunnel to begin, by fulfilling mitigation requirements associated with the project.

**SB 1319 (Burton) California Ocean Protection Act**

This bill establishes the Ocean Protection Council, consisting of the Secretary for Resources, Secretary for EPA, Chair of the State Lands Commissions and six members of the Legislature. The bill would require the council to coordinate and integrate the activities of state agencies active in the areas of ocean ecosystems and coastal waters. The activities of the council would be supported with existing resources. The bill would also create the Ocean Protection Trust Fund, and authorize funds to be deposited in the account for appropriation by the Legislature.

**SB 1369 (Kuehl) Fire protection**

This bill requires that the owner or occupant of a dwelling in a very high fire hazard severity zone, as defined in Govt. Code Section 51179, remove all flammable brush, vegetation and combustible growth within 100 feet of the structure, unless local ordinance requires greater clearance. The bill would authorize the Director of Forestry and Fire to cause the fire clearance to take place if a property owner does not comply.

**SB 1459 (Alpert) Fishing: trawl nets**

This bill grants the Department of Fish and Game authority over all state-managed bottom trawl fisheries, require a permit for all trawling activities, require that a previously held trawl permit be a requirement for obtaining a new or renewed permit by 2007, prohibit the use of certain types of trawl gear, authorize the Fish and Game Commission to facilitate programs that promote the conversion of trawl vessels to more sustainable practices, and prohibit trawling activities in portions of Monterey Bay, Estero Bay and San Luis Obispo Bay.

**SB 1742 (McPherson) Oil spills**

This bill amends state Oil Spill Contingency Plan to specifically include waterways used for waterborne commercial traffic in the ports of Stockton and Sacramento; defines an oil spill or discharge as the release of at least 1 barrel of oil over a 24 hour period; includes wildlife rehabilitation as an allowable activity for volunteer workers; adds the state of Hawaii to the list of coastal states with whom the administrator shall coordinate oil spill prevention activities; makes non-substantive, technical changes and deletes obsolete sections of the code.
