The Coastal Commission staff has reviewed the above-referenced negative determination for a coastal watershed restoration program subcomponent consisting of three restoration projects at the Point Reyes National Seashore to improve fish passage and repair or restore existing facilities. The improvements are located at two water impoundments (Muddy Hollow and Limantour Beach Pond), and one road crossing (Glenbrook Crossing). The restoration projects would consist of removing an existing dam and spillway at Muddy Hollow, replacing an existing culvert with a bridge crossing at Limantour Beach Pond, and restoring the Glenbrook Crossing to a more natural gradient.

The projects would restore natural hydrologic functions, increase flood conveyance and reduce parriers to fish passage, and would include Best Management Practices to protect water quality and measures to avoid impacts to sensitive wildlife species, including migratory birds and the California red legged frog.

The Coastal Commission staff has received your request to identify Commission jurisdiction regarding the federal consistency process. Pursuant to the federal Coastal Zone Management Act (CZMA), a federal agency cannot issue a permit for an activity, either in or out of the coastal zone, that affects land and water uses or natural resources of the coastal zone until the applicant has complied with the requirements of Section 307(c)(3)(A) of the CZMA. (16 USC Section 1456[c][3][A].) These requirements can be met by receiving a Commission concurrence with a consistency certification prepared by the applicant or conclusion that the activity does not affect the coastal zone. Alternatively, these requirements can be satisfied by the issuance of a Commission approved coastal development permit. Since the federal consistency authority cannot be delegated to local governments, a coastal development permit issued by a local agency does not replace the requirement for a consistency certification. The Coastal Commission staff has reviewed the information submitted for the above-referenced project, and has concluded as follows:

The Coastal Commission declines to assert federal consistency jurisdiction, due to the fact that:
(1) this project constitutes repair and maintenance and is exempt from the need for a locally issued coastal development permit; and (2) the project does not raise significant issues with respect to coastal resources.

On July 29, 2003, we concurred with your negative determination for the National Park Service's (Park Service) Heart-of-the-Park Shuttle Demonstration Project for the Santa Monica Mountains National Recreation Area (Recreation Area)(ND-45-02). In that determination the Park Service proposed the operation of a tourist shuttle system to serve popular sites within the Recreation Area, including travel in a bi-directional loop around the central part of the park, using Malibu Canyon Road, the Pacific Coast Highway, Kanan Dume Road, and the Mulholland Highway, and including stops at 13 sites including Malibu Creek State Park, Malibu Lagoon State Beach, Solstice Canyon, Zuma Beach, Paramount Ranch, Tapia Park, Backbone Trailhead, Rocky Oaks, Peter Strauss Ranch, and four other flag stop sites.

The Park Service currently proposes to relocate one of the shuttle bus parking areas from Malibu Creek State Park (the "Reagan Ranch" site) to the Diamond X Ranch off Mulholland Drive to the east. To implement this modification, the Park Service proposes expanding an existing parking lot by approximately 19,000 sq. ft., where the Park Service would park the shuttle buses when not in use. The project would include water quality controls and Best Management Practices. The site contains no vegetation or sensitive habitat, and it already has an aggregate base and is informally used for parking.

In our previous negative determination concurrence, we agreed that the program would improve public access and recreational resources of the coastal zone by providing transportation to several coastal recreation areas and public beaches, would reduce vehicular traffic within the Santa Monica Mountains, would involve construction activities adjacent to existing roads, parking areas, and other park facilities and will be visually consistent with these areas, would avoid adverse effects on sensitive biological resources, would include measures to protect water quality, and would improve air quality by providing an alternative means of transportation to recreational areas in the Santa Monica Mountains.

Under the federal consistency regulations (Section 930.35), a negative determination can be submitted for an activity "which is the same as or similar to activities for which consistency determinations have been prepared in the past." This project is similar to the above-referenced negative determination with which we previously concurred (ND-45-02) and does not raise any new coastal resource issues not previously considered.
