MEMORANDUM

Subject: Request to extend the time limit to acknowledge and accept the modifications suggested

by the Coastal Commission on LCP Major Amendment 1-06 Part 2 (Fiscalini Ranch).

At the July 11, 2007 Coastal Commission meeting in San Luis Obispo, the Commission denied, and then approved if modified by the Commission's suggested modifications, San Luis Obispo County Local Coastal Program (LCP) Major Amendment Number 1-06 Part 2 (Fiscalini Ranch). This LCP amendment changed the underlying land use designations and established allowable uses on the 430-acre Fiscalini Ranch located in Cambria.

Pursuant to the Commission's regulations, the County has six months from the date of Commission action to accept the Commission's suggested modifications, in this case by January 11, 2008 (California Code of Regulations (CCR) Section 13537). If the County has not accepted the suggested modifications by that time, then the Commission's approval with suggested modifications expires at that time, and only the Commission's denial stands.

Coastal Act Section 30517 and CCR Section 13535(c) provide that the Commission may extend, for good cause, time limits related to LCPs for a period not to exceed one year. On October 29, 2007 the County requested a one-year extension of time to accept the modifications suggested by the Commission (see County's letter attached). In this case, the requested time extension will allow further County consideration of the Commission's suggested modifications. A one-year extension would result in a new deadline for the County to accept the Commission's suggested modifications on the proposed amendment of January 11, 2009. Although staff believes that this matter will be resolved well before the new deadline, it is appropriate in this case to extend the deadline for a full year as provided by the Coastal Act and the Commission's regulations. Therefore, staff recommends a one year extension of time.

Summary of the Staff Recommendation

Staff recommends that the Commission extend the expiration date of its approval with suggested modifications, and thus extend the six month time limit that applies to the County's acceptance of the Commission's suggested modifications, for a period of one year (to 1/11/09).

Motion. I move that the Commission extend the six month time limit for San Luis Obispo County to accept the Commission's suggested modifications that apply to Local Coastal Program Amendment Number 1-06 Part 2 by a period of one year.

Staff Recommendation. Staff recommends a **YES** vote. An affirmative vote of a majority of the Commissioners present is needed to pass the motion.
