**SUBJECT:** Channel Islands Harbor Public Works Plan Amendment 1-07 (Waterside Improvements): Executive Director's determination that the County's acknowledgement of receipt, acceptance, and agreement with the Commission's certification with suggested modifications is legally adequate. This determination will be reported to the Commission at the December 11, 2008 hearing in San Francisco.

On February 8, 2008 the Commission approved Channel Islands Harbor Public Works Plan Amendment 1-07 (Waterside Improvements) with suggested modifications. On October 16, 2008, the Commission approved revised findings for Public Works Plan Amendment 1-07. The amendment to the Public Works Plan (PWP) includes revisions to allow reconstruction, replacement, and maintenance of marinas and boater related amenities, allow pierhead expansions, and allow other changes in the policies of the PWP relating to waterside uses of the harbor.

Pursuant to Section 13544 of the California Code of Regulations, Title 14, Division 5.5, the Executive Director must determine that the action taken by the County of Ventura acknowledging receipt and acceptance of, and agreement with the Commission's certification of the above referenced PWP amendment with suggested modifications is legally adequate and report that determination to the Commission. The certification shall become effective unless a majority of the Commissioners present object to the Executive Director's determination.

I have reviewed the County's acknowledgement and acceptance of, and agreement with the terms and suggested modifications of PWP Amendment 1-07, as certified by the Commission on February 8, 2008 and October 16, 2008, as contained in the adopted Resolution of November 25, 2008, and find that the County's action and notification procedures for appealable development are legally adequate to satisfy the terms and requirements of the Commission's certification. I therefore recommend that the Commission concur in this determination.

ACKNOWLEDGING RECEIPT, ACCEPTING AND APPROVING  
THE CALIFORNIA COASTAL COMMISSION'S CONDITIONAL  
CERTIFICATION OF THE CHANNEL ISLANDS HARBOR PUBLIC WORKS  
PLAN AMENDMENT No. 1-07 REGARDING WATERSIDE RECREATIONAL  
BOATING**

**WHEREAS**, the Channel Islands Harbor Public Works Plan ("PWP") was certified by the California Coastal Commission on September 19, 1986; and

**WHEREAS**, the Board of Supervisors of the County of Ventura ("Board"), after considering all written and oral testimony, County staff reports and recommendations, approved a PWP amendment at a legally noticed public hearing on March 13, 2007, in order to update policies related to waterside recreational boating; and

**WHEREAS**, the California Coastal Commission, after considering all written and oral testimony, Coastal Commission staff reports and recommendations, approved and conditionally certified Amendment No. 1-07 to the PWP with 32 modifications by a vote of 8 to 2 on February 8, 2008; and

**WHEREAS**, the California Coastal Commission, on October 16, 2008, adopted Revised Findings for PWP Amendment No. 1-07, including 32 modifications by a unanimous vote of the Commissioners who were present and eligible to vote on this matter; and

**WHEREAS**, the Board now desires to complete the certification of PWP Amendment 1-07 by acknowledging receipt of and accepting the modifications and conditions adopted by the California Coastal Commission.

**NOW, THEREFORE, BE IT RESOLVED, ORDERED, AND DETERMINED THAT** the Board acknowledges receipt of, accepts, and approves of the California Coastal Commission's approval and conditional certification of PWP Amendment No. 1-07, with suggested modifications, on October 16, 2008, in compliance with California Code of Regulations, title 14, sections 13551, subdivision (b), and 13544, subdivision (a).

**FINALLY, BE IT RESOLVED, ORDERED, AND DETERMINED THAT** the Channel Islands Harbor Public Works Plan Amendment No. 1-07 shall become final, effective and operative upon the California Coastal Commission's concurrence with its Executive Director's determination pursuant to California Code of Regulations, title 14, section 13544.


