Subject: Final Coastal Commission Certification Review for City of Marina Local Coastal

Program Amendment Number 1-07 Part 4 (Subdivisions)

At the April 10, 2009 Coastal Commission meeting in Oxnard, the Commission approved, with suggested modifications, City of Marina Local Coastal Program (LCP) Major Amendment Number 1-07 Part 4. The amendment revised the LCP's Implementation Plan to establish a new set of updated subdivision regulations.

By action taken September 1, 2009, the City of Marina adopted the amending LCP text as directed by the Commission's suggested modifications (see Exhibit A). This action was taken within the required six month timeframe.

The Executive Director has determined that the actions taken by the City are legally adequate and that the amended LCP should be certified. The Executive Director recommends that the Commission concur with this determination and that the LCP, as amended, be certified. If the Commission concurs, the amended LCP will be certified as of today's date (i.e., October 07, 2009), and notification of this certification and Commission concurrence will be forwarded to the City.

Motion. I move that the Commission concur with the Executive Director's determination that the actions taken by the City of Marina to accept the Commission's suggested modifications for LCP Amendment 1-07 Part 4 are legally adequate.

Executive Director's Recommendation. The Executive Director recommends a **YES** vote on the motion. Passage of this motion will result in certification of the City of Marina LCP as directed by the Commission's approval with suggested modifications of LCP Amendment 1-07 Part 4; the amended LCP will be certified as of today's date (i.e., October 07, 2009). The motion passes only by affirmative vote of a majority of the Commissioners present.

ORDINANCE NO. 2009-04

ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MARINA AMENDING TITLE 16
OF THE MARINA MUNICIPAL CODE ENTITLED "SUBDIVISIONS".

THE CITY COUNCIL OF THE CITY OF MARINA DOES ORDAIN THAT:

ONE, CONSISTNECY WITH STATE LAW: It is hereby found and determined that the proposed amended Title 16, entitled "Subdivisions," as shown in "EXHIBIT A" attached hereto ("Proposed Amended Title 16") is consistent with the Subdivision Map Act in that it incorporates state standards and procedures as appropriate.

TWO, CONSISTENCY WITH THE GENERAL PLAN AND THE LOCAL COASTAL PROGRAM. It is hereby found and determined that the Proposed Amended Title 16 is consistent with the goals, policies and programs of the Marina General Plan and Local Coastal Program, in that the amendment implements General Plan and Local Coastal Program policies related to community character and coastal protection and access.

THREE, CONSISTENCY WITH THE CALIFORNIA ENVIRONMENTAL QUALITY ACT. It is hereby found and determined that the Proposed Amended Title 16 is exempt from environmental review pursuant to the General Rule of the California Environmental Quality Act (CEQA) that exempts minor alterations to land use limitations that do not result in changes in land use or density pursuant to CEQA Guidelines Section 15305.

FOUR, TITLE 16 AMENDED. Title 16 of the Marina Municipal Code is hereby deleted in its entirety and replaced with a new Title 16, entitled "Subdivisions," to read as shown in "EXHIBIT A" attached hereto.

FIVE, EFFECTIVE DATE. This Ordinance shall take effect and be in full force upon the 30th calendar day after its final passage and adoption.

SIX POSTING OF ORDINANCE. Within fifteen (15) calendar days of the adoption of this Ordinance, the City Clerk shall cause it to be posted in three (3) public places designated by Resolution of the City Council.
