Subject: **Possible Changes in Commission Meeting Schedule for the Remainder of 2011 and Possible Changes in Recently Adopted 2012 Commission Meeting Schedule. For Commission discussion and possible action on July 13, 2011, Item W16a**

At the request of Commissioners and with direction from the Chair, staff reviewed the meeting locations for the remainder of the 2011 calendar and the adopted 2012 calendar to determine if the meeting locations can be spread out over the year in a better pattern.

2011

We reviewed the remaining months of the 2011 calendar and Commission meeting locations. The only meeting that is feasible to change in 2011 is the September meeting. The September meeting has typically been in Eureka so that the Commission meets at least once per year in the most northern section of coast. September is typically a good travel weather month on the North Coast. Commissioner McClure has a possible location for a meeting in September 2011 in Crescent City. **The Commission could choose to meet in September 2011 in Crescent City instead of Eureka or choose to keep the meeting in Eureka.**

Staff is researching travel and hotel options for Crescent City and will have additional information to discuss with the Commission at the July meeting. The Commission has not met in Crescent City and holding a meeting in Crescent City in September would give the Commission an opportunity to hold a field trip and see the area.

2012

Staff recommends that the Commission revise its 2012 meeting calendar as shown on the Recommended Revised Schedule.

The Recommended Revised Schedule has the same number of northern and southern locations. However, as revised, it disperses the meetings so that northern and southern locations alternate as much as possible.
