

COMMISSION FIELD TRIP TENTATIVE ITINERARY

- 10:45 AM CCC Tour Bus departs Sheraton Fisherman's Wharf. (Maximum capacity 24 passengers; CCC staff maintaining passenger list)*
- 11:10 AM Passengers attending in Caltrans Tour Van arrive at the Caltrans' Devils Slide Construction Office, located at 585 Linda Mar Blvd. in Pacifica, next to the SamTrans Park & Ride lot, for mandatory safety briefing. (Passengers on CCC bus will receive safety briefing enroute.)
- 11:30 AM CCC Bus and Caltrans Tour Van arrive at Devils Slide South Portal to observe tunnel.
- 11:35 AM Safety equipment provided to passengers as they disembark from Bus
- 11:45 AM Depart South Portal for North Portal.
- 11:55 AM Arrive North Portal to observe tunnel, bridge and Shamrock Ranch mitigation areas.
- 12:20 PM Depart North Portal.
- 12:25 PM Members of Public on Caltrans' Van Arrive Pacifica Construction Office

*Note:

- 1. <u>No</u> private vehicles will be allowed on the Devil's Slide Tunnels portion of the tour. All members of the public participating <u>must be signed up prior to the field trip and must travel</u> to the tunnels either in the CCC bus or Caltrans' van.
- 2. Caltrans' van at Pacifica can provide for a maximum of 12 additional members of the public who might wish to attend the tunnels tour. <u>Space is available on a first-come first-serve basis to those who contact CCC staff at 831-427-4863 prior to Dec 13 or at the CCC hearing room the day of the field trip.</u>
- 3. All attendees travelling to Pacifica separately are to park their personal vehicles at the Park & Ride Lot; other participants wishing to go to the subsequent field trip stops in Pacifica may also wait at the Park & Ride Lot during the tunnels tour.
- 4. All tunnels tour participants must attend a safety briefing to be presented by Caltrans, and must sign a liability waiver and release.
- 5. All tunnels tour participants must wear personal protective equipment, provided by Caltrans, consisting of hard hat, safety glasses, and hi-visibility reflective vest.
- 6. Appropriate clothing and footwear is required, as the tunnels tour will be conducted within an active construction site. Participants must wear sturdy hiking-type boots/shoes. No open-toe, sandal, high heel, or sport-type (i.e., tennis, basketball, running) footwear is allowed. Long pants must also be worn, as dresses, and shorts are not allowed on a construction site.
