• Page 1, Section 1.4.1, line 1 is changed to read as follows:

Development within the <u>dD</u>eed-restricted <u>aA</u>rea, <u>as defined in Section 4.3</u>, <u>below</u>, that is unpermitted and / or inconsistent with CDP No. 5-85-057 or CDP No. 4-97-077....

• Page 15, Section 7.0 is changed to read as follows:

The recorded document shall reflect that no development, as defined in PRC Section 30106, shall occur within the Deed Restriction Area <u>Open Space Area</u>, as defined in Section 4.7, except as otherwise set forth in the Deed Restriction, as described below....

This law firm represents Eric and Barbara Linder (the "Linders") with respect to the abovereferenced matter. We urge you to accept Staff's recommendation to approve Consent Cease and Desist Order No. CCC-12-CD-04 and Consent Restoration Order No. CCC-12-RO-04 (the "Consent Orders") as proposed. The Linders signed the Consent Orders on August 24, 2012 and have, therefore, agreed to accept all terms as proposed for the Commission's approval.

Please note that despite the Linders' agreement with the Consent Orders, the Linders do <u>not</u> agree with all of the Staff's findings of fact. The Staff Report and findings were not provided to the Linders until after they signed and agreed to the Consent Orders and, as such, the Linders waiver of their right to contest the findings only applies to the Consent Orders and not to any other document or proceeding.

Due to the distant location of the Commission meeting, our clients will not be able to attend or be represented at the September 13th hearing. We do, however, respectfully request that you approve the Consent Orders as recommended by Commission staff.
