**SUBJECT:** County of Santa Barbara LCP Amendment MAJ-3-11-B (Commercial Telecommunication Facilities Ordinance): Executive Director's determination that the County's acknowledgement of receipt, acceptance, and agreement with the Commission's certification with suggested modifications is legally adequate. This determination will be reported to the Commission at the Thursday, November 14, 2013 hearing in the City of Newport Beach.

On April 10, 2013, the Commission approved Local Coastal Program Amendment No. MAJ-3-11-B, submitted by the County of Santa Barbara, with suggested modifications. This amendment modifies the Implementation Plan/Coastal Zoning Ordinance (IP/CZO) portion of Santa Barbara County's certified Local Coastal Program (LCP) to provide new procedures and development standards that regulate the construction and use of commercial telecommunication facilities.

On September 3, 2013, the County Board of Supervisors adopted Resolution No. 13-213 (attached) acknowledging receipt of the Commission's certification of LCP Amendment No. MAJ-3-11-B and accepting and agreeing to all modifications suggested by the Commission.

Pursuant to Section 13544 of the California Code of Regulations, Title 14, Division 5.5, the Executive Director must determine that the action taken by the County of Santa Barbara acknowledging receipt and acceptance of, and agreement with the Commission's certification of the above referenced LCP amendment with suggested modifications is legally adequate and report that determination to the Commission. The certification shall become effective unless a majority of the Commissioners present object to the Executive Director's determination.

I have reviewed the County's acknowledgement and acceptance of, and agreement with the terms and suggested modifications of LCP Amendment MAJ-3-11-B, as certified by the Commission on April 10, 2013, as contained in the adopted Board Resolution of September 3, 2013, and find that the County's action and notification procedures for appealable development are legally adequate to satisfy the terms and requirements of the Commission's certification. I therefore recommend that the Commission concur in this determination.

WITH REFERENCE TO THE FOLLOWING:

- A. Whereas on May 17, 2011, the Board of Supervisors of the County of Santa Barbara approved an amendment to the County's Local Coastal Program by amending the Coastal Zoning Ordinance, Article II of Chapter 35, Zoning, of the County Code, regarding the processing of applications for commercial telecommunication facilities (Ordinance No. 4789, Case No. 11ORD-00000-00007); and
- B. Whereas on December 13, 2011, the Board of Supervisors of the County of Santa Barbara, by Resolution No. 11-413 submitted said amendment for consideration and certification to the California Coastal Commission; and
- C. Whereas on April 10, 2013, the California Coastal Commission approved a resolution of certification with suggested modifications for this amendment to County's Local Coastal Program (Coastal Commission Case No. STB-MAJ-3-11-B); and
- D. Whereas the Board of Supervisors finds the suggested modifications to be acceptable;


NOW THEREFORE, IT IS HEREBY RESOLVED AS FOLLOWS:

- 1. The above recitations are true and correct.
- 2. The Board of Supervisors acknowledges receipt of the California Coastal Commission's resolutions of certification with suggested modifications and accepts and agrees to those modifications through amendment of the Coastal Land Use Plan and Implementation Program (Coastal Zoning Ordinance) as required in Section 13544(a) of the Commission's Administrative Regulations, and agrees to issue Coastal Development Permits for the total area included in the certified Local Coastal Program consistent with the modifications of Ordinance No. 4789 as certified by the Commission.
- 3. The Board of Supervisors will submit this acknowledgment to the California Coastal Commission to demonstrate conformity with the provisions of the Commission's action to certify the amendment to the Local Coastal Program in compliance with Section 13544(b) of the Commission's Administrative Regulations.

4. The Chair of the Board of Supervisors is hereby authorized and directed to sign and certify all documents and other materials in accordance with this Resolution to reflect the above mentioned action by the Board of Supervisors.
