Replacement of an existing 370 square foot Seadrift Lagoon intake pier and 1130 square foot boat launch ramp at 210 Dipsea Road and 307 Seadrift Road in Bolinas Lagoon, Marin County.

Executive Director's Waiver Determination

Pursuant to Title 14, Section 13238 of the California Code of Regulations, and based on project plans, proposed limitations on development, and other application materials submitted by the applicant regarding the proposed development, the Executive Director of the California Coastal Commission hereby waives the requirement for a CDP for the following reasons:

The proposed project will facilitate water-oriented recreational activities at a private boat launch that also provides access to fishermen from Bolinas. The proposed pier and boat launch is adequately sited and designed to avoid impacts to coastal resources and will be located within the footprint of the existing intake pier and boat launch. The project includes construction methods and best management practices to avoid and minimize potential impacts to the water quality and biological resources of Bolinas Lagoon. The project has been reviewed and authorized by Marin County, San Francisco Bay Regional Water Quality Control Board, U.S. Army Corps of Engineers, United States Fish and Wildlife Service, and Gulf of the Farallones National Marine Sanctuary. For the reasons above, the proposed project is consistent with Chapter 3 of the Coastal Act.

Coastal Commission Review Procedure

This waiver is not valid until the waiver has been reported to the Coastal Commission. This waiver is proposed to be reported to the Commission on December 11, 2014, in Monterey. If four or more Commissioners object to this waiver at that time, then the application shall be processed as a regular CDP application.
