#### RULES

**NOTE: Speakers are encouraged to co-ordinate testimony. All those who want to testify must fill out a speaker's slip before the start of the hearing which will be no sooner than 10:00 am. Commission staff will be located at a table to assist those who would like to speak.**

1. Executive Director's statement - **30 minutes maximum.**
2. Elected officials and Public Agency Representatives – **Maximum of 2 minutes each.**
3. Organized Groups get **\*\*10 minutes maximum per group.** (*Register with staff to be considered an organized group.*)
4. Individual members of the public – **Maximum of 2 minutes each.**
5. **Ceding of time** from one speaker to another is allowable up to maximum of 5 individuals ceding their time to one speaker for a maximum of 10 minutes of speaking time. Those wishing to cede their time must register with the staff on the speaker slips before the hearing.
6. **No audible outburst will be allowed.** You may wave your hands to show your support or give the thumbs down to signal your opposition.
7. **Visual Presentations/Materials.** Powerpoint presentations must be accompanied by a USB flash drive, flash memory card, or compact disk. All electronic formats must be PC compatible. Files created on a Mac might not be supported. It is recommended that a hard copy of any electronic presentation be submitted in case of technical difficulties. A slide projector & laptop will be available from our audio-visual technician, and they can assist you in its use.

***Note: To preserve adequate time for Commission deliberation, the Chair reserves the right to close the public hearing after a reasonable opportunity to present all questions and points of view has been allowed.***

#### **Coastal Act Section 30335 Executive Director**
