**SUBJECT:** **University of California, Santa Barbara LRDP Amendment No. LRDP-4-UCS-16-0001-1 Part A (Coal Oil Point Reserve Management Plan) and Part B (Various) Time Extension** to be heard at the June 7, 2017 Commission Hearing in Arcata.

The University of California at Santa Barbara has submitted an amendment to its certified Long Range Development Plan (LRDP) to: (A) incorporate the Coal Oil Point Reserve Management Plan into the LRDP, including policy and map revisions and (B) correct inadvertent text errors and make corrections to the LRDP boundary on applicable LRDP figures to exclude a privately owned parcel. On May 9, 2017, the Executive Director determined that the University's amendment submittal was in proper order and legally adequate to comply with the submittal requirements of Coastal Act Section 30510(b). Pursuant to California Code of Regulations, Title 14, Section 13522, an amendment to the certified LRDP must be scheduled for a public hearing and the Commission must take action no later than 60 days from the date the amendment was properly submitted. In the subject case, the 60<sup>th</sup> day will be July 8, 2017.

Coastal Act Section 30517 and California Code of Regulations, Title 14, Section 13535(c) state that the Commission may extend for good cause the 60-day time limit for a period not to exceed one year. Commission staff is requesting an extension to the 60-day time limit in order to allow adequate time to review and analyze the amendment. Staff is planning to tentatively schedule the subject LRDP amendment for a Commission hearing in late 2017. Staff recommends that the Commission extend the deadline for a full year as provided by the Coastal Act to allow for uncertainty in the review process and flexibility for coordinating with the University of California, Santa Barbara, establishing hearing schedules, and managing competing workload items. Therefore, staff recommends that the Commission extend the 60-day time limit to act upon the subject University of California, Santa Barbara LRDP Amendment No. LRDP-4-UCS-16-0001-1 Parts A & B for one year.

### **STAFF RECOMMENDATION**

Staff recommends that the Commission vote to extend the deadline for Commission action for one year.

**MOTION:** *I move that the Commission extend the 60-day time limit to act on the University of California, Santa Barbara Amendment No. LRDP-4-UCS-16-0001-1 Parts A & B for one year.*

**RECOMMENDATION:** Staff recommends a **YES** vote. An affirmative vote of a majority of the Commission present is needed to pass the motion.
