Dear Ms. Brown:

The Coastal Commission staff has reviewed the above-referenced negative determination for the Green Waste Disposal project, which consists primarily of the removal of dried, invasive vegetation using prescribed burning, on the Bureau of Land Management's (BLM's) Humboldt Bay South Spit Cooperative Management Area. Methods of removal other than burning may be implemented (i.e., composting, shipping, or trucking offsite) if some of the material is not sufficiently desiccated to be burned. The burning would occur in accordance with oversight from the local Air Quality Management District. Burning would not occur during the snowy plover nesting season if plovers are present. No burn piles would be sited on or near environmentally sensitive habitat (i.e., beach layia and Menzies' wallflower) or culturally sensitive areas.

Under the federal consistency regulations, a negative determination can be submitted for an activity "which is the same as or similar to activities for which consistency determinations have been prepared in the past." The Commission and staff have previously authorized BLM prescribed burning on the South Spit, through Consistency and Negative Determinations ND-047-08, ND-094-03, and CD-052-02 (the South Spit Interim Management Plan). The proposed burning would include similar resource protection measures to those in the previously-authorized activities, and with the measures, the activity would not adversely affect coastal resources. We therefore **concur** with your negative determination made pursuant to 15 CFR 930.35 of the NOAA implementing regulations.
