



## Existing O&M *tšumaš* Creek scope of activities:

- A. Staging will be limited to disturbed non-vegetated areas.
- B. O&M forces will not use lot C for BEMP purposes, as mentioned in earlier sheets. Lot C will only be used to get to the existing ACCESS ROAD west of tšumaš Creek.
- C. Staging or storing on 'Access Road' overnight will not be done for BEMP purposes. Occasionally auxiliary generators or equipment are stored at the O&M Access Road west of tšumaš Creek for channel, road and fence maintenance, conducted in compliance with BMPs.

GENERAL NOTES(CITY OF PORT HUENEME ENCROACHMENT PERMIT CONDITIONS): The Permittee shall notify the City of Port Hueneme at 805-797-0095 (if no answer, leave a voice mail) not less than 24 hours' time prior to entering City Property, and each time, when utilizing the access point.

Work hours shall be restricted to the hours between 7:00 am to 4:00 pm, Monday through Friday. No work shall take place on City recognized holidays.

The City of Port Hueneme's permit for this project authorizes employees of the Permittee only, the right to pass and re-pass with vehicles, equipment, tools, and materials, whenever deemed necessary by the Permittee, upon City property, utilizing the access point and routes indicated diagrammatically on Sheets 1 and 2 of these plans. All the above is subject to the terms and Conditions and the Special Conditions set forth by the Permit.

This project's Permit specifically does not authorize the construction or installation of improvements of any nature or kind on or along an the access route, whether temporary or permanent.

Special care shall be taken to protect in-place all existing improvements including, without limitation, plant life. Travel of any kind on existing turf areas is expressly prohibited.

Only rubber-tire vehicles and equipment shall be placed on asphalt and concrete pavements and aggregate base access ways. Tracked equipment shall be placed and operated on beach sand only, and transport vehicle stabilizers, outriggers, and travel beds shall be placed on either aggregate base access ways or beach sand only.

Access for construction vehicles and tractors to the area of the beach where sand elevation management activities will occur shall be limited to only the designated Access routes.

### **Special Requirements for the Access Route:**

REVISION DESCRIPTION

- A. Take the most direct route practicable from the Access Point to the wet-sand hard-pack surf zone as reflected daily by the mean high tide level.
- B. Travel the wet-sand hard-pack surf zone only to the Beach Elevation Management Plan (BEMP) location.
- C. A dedicated "spotter" shall accompany, on foot, each piece of equipment as it travels an access route to the BEMP location. A qualified biologist shall accompany the equipment from the parking lot to the BEMP, and oversee BEMP activities.
- D. The access Route is available at parking lot A and B. Take special care to watch for the activity of others, especially children that may be playing on, or may be partially buried in, the sandy beach.
