

Dear Members of the California Coastal Commission,

I am one of the appellants and I urge you to find substantial issue with the Lincoln Apartments project, Appeal No. A-5-VEN-20-0060. The Coastal Commission staff report ignores many things, including evidence presented regarding the over concentration of projects in Venice. I implore you to read the complete Grounds for Appeal filed by the appellants, which outlines why Lincoln Apartments is not consistent with Chapter 3 of the Coastal Act. Here are some of the reasons:

Rebuttal to Staff Report for Appeal:

- 1 Zero Residential Parking and Reduced Commercial Parking
- 2 This project is inconsistent with the community character of the surrounding area
- 3 Concentration of projects in Venice
- 4 Community Opposition

1 - Zero Residential Parking and Reduced Commercial Parking

- a. Zero Residential Parking sets a dangerous, statewide precedent
- b. SPY should not receive residential parking waivers, as they will mainly serve non-residents
- c. Staff ignored parking requirements for 4,441 sq ft of the project
- a. Zero residential parking raises a substantial issue and sets a dangerous statewide precedent. (Coastal Act Section 30252 states: "providing adequate parking facilities")

This is a 30,463 square foot project with only 6 parking spaces! As outlined in the Grounds for Appeal submitted to staff, this project should have 132 total parking spaces, according to the LUP. If this building is going to get built, it must be properly parked.

Reduced parking and zero parking are not the same thing. According to the study cited by Coastal Commission staff, there should be 8-19 residential parking spaces for this project, not zero

residential parking spaces. It seems as if staff is equating bicycle parking to automobile parking. There is no evidence that there will be zero demand for residential parking. In fact, zero residential parking is unprecedented.

With parking already scarce in this coastal neighborhood, the lack of parking spaces provided in this project will degrade the neighborhood. Lack of onsite parking not only causes project related vehicles to be parked in neighborhood near the development, it also causes increased traffic as motorists circle the block looking for a parking space.

Mass transit cannot be relied upon. Metro has published studies that show that bus ridership is down dramatically. This link shows the evidence of this claim.

If this project gets approved, as presented, then permit parking should be allowed in this neighborhood. Coastal staff stated multiple times that this is an inland area of the coastal zone and coastal access isn't an issue, so parking permits should be allowed on nearby streets to make up for this egregiously under parked project.

If this project gets approved, as presented, it will set a precedent for any similar project to get approved anywhere in the coastal zone with zero residential parking.

b. Safe Place for Youth (SPY), an onsite nonprofit, should not receive residential parking waivers, especially when you consider the vast majority of their clients will be non-residents. This sets a dangerous precedent for any nonprofit to be egregiously under parked if they are part of an affordable housing project. SPY serves 75-100 clients on any given day, and only 19 of those clients will be residents. There is no reason for them to receive a reduction in parking spaces. At 3,085 square feet, there should be 13 parking spaces just for SPY, according to the Land Use Plan.

SPY has stated that they currently have 69 employees and 20 volunteers, on any given day. They also serve meals to 75-100 clients each day they are open.

c. Coastal staff gave no adequate reason as to why the 4,441 square feet of space for supportive services requires zero parking spaces, when according to the LUP, it should require 18 parking spaces. The staff report states that it is considered accessory to the residential use and therefore should not be subject to parking requirements, yet offers no justification.

The staff report also states that 3 full-time professional social service staff will occupy this space, and additional space is reserved for multiple service partners. These employees need a place to park. There is no reason this area should be exempt from parking requirements.

2 - This project is inconsistent with the community character of the surrounding area

- a. Plans to commandeer public parking spaces for loading and deliveries
- b. Safety concerns
- a. The staff report incorrectly states "All vehicle access will be provided from an existing 10-footwide driveway on Garfield Ave." This is false. A summary of a legally binding Memorandum of Understanding states that for this project, "All loading and delivery activities will use the public parking spaces on Lincoln Blvd." Coastal staff completely ignored the fact that VCH plans to commandeer public parking spaces on Lincoln Blvd for loading and deliveries. Staff also ignored plans for the parking lane of Lincoln Blvd to become mass transit lane in the future. Neighboring streets will, no doubt, be used for loading and deliveries, of which there will be many. Also, this project is expected to have many emergency vehicle visits. These delivery trucks and emergency vehicles will be parking in the neighborhood, double-parking, and causing traffic problems. This is not consistent with the community character of the surrounding area.
- b. Coastal staff ignored the large number of Police/Fire responses to SPY and VCH's buildings and stated that the project was compatible with the neighborhood. In the last two years, Gateway Apartments, VCH's largest supportive housing project (with only 20 units, which is half the size of this Project), had 129 Police and Fire Department responses. A market rate apartment building on the same block had only 11 Police and Fire Department calls in the same time frame. *VCH's building has 11 times more police and fire responses than the nearby comparable building.* Some of the calls were for: Missing Child, Assaults with a Deadly Weapon, Batteries, Burglaries, and Thefts. VCH's Horizon apartment building has similar egregious police and fire response responses.

Police and Fire departments have been called to SPY 117 times in the last three years — for incidents such as Assault with a Deadly Weapon, Violent Mentally III, Overdose, Battery, Burglary, and Vandalism. There was even a chain wielding man from SPY who threatened people and smashed windows, causing a lockdown at St. Mark School and shutting down Garfield Ave so that children could not get home after school. It is also important to note that those calls have occurred with the operation of a part time, program operating three afternoons a week. The proposed Project plans to expand SPY services to seven days a week, thus exacerbating the police and fire responses to this location. SPY also has a large number of police/fire responses to its operations at A Bridge Home in Venice, with a large increase in encampments and violent crimes around that site since it opened.

LA City Planning Commissioner Marc Mitchell stated in the CPC Hearing, ""I volunteered at SPY and....I personally have seen disorganization at the site that does lead to safety issues."

Section 30210 of the Coastal Act states, in part:

...maximum access, which shall be conspicuously posted, and recreational opportunities shall be provided for all the people **consistent with public safety needs** and the need to protect public rights, and rights of private property owners, and natural resource areas from overuse.

With these documented safety issues in mind, this project is clearly not compatible with the neighborhood. Who will be held liable when someone gets hurt?

3 - Concentration of projects in Venice

In the staff report, Coastal staff lumped Venice into a generic "coastal zone", without studying Venice, specifically. The Staff report states; "there is no evidence that this project is part of a concerted City plan to locate affordable housing developments in the project vicinity in a way that would significantly affect the character of the surrounding area."

In fact, there was evidence provided: a study done by Pacific Urbanism was provided to Coastal Commission staff and ignored. According to Pacific Urbanism, Venice has the 8th highest rate of affordable housing in all of Los Angeles (with 1860 low income and supportive housing units), and the highest rate, by far, in Council District 11. And this is not including the many planned projects: Thatcher Yard, Reese-Davidson Project, Rose Ave, Lincoln Apts, etc. — which is an additional 466 units - which brings it to over 2300 low income and supportive housing units in Venice. Not even including the planned projects, Venice has over 5 units of affordable housing per 100 people. Pacific Palisades and Brentwood combined have .21 units of affordable housing per 100 people.

There are many news outlets that have referred to Venice as "Skid Rose" (a reference to Skid Row, another area with an over concentration of housing). So, yes, the character of the surrounding area is being affected significantly, as evidenced by many news reports.

Along with the over concentration of affordable housing and services in Venice (3.1 square miles), the homeless population has gone up by 60% in Venice, while going down 77% in Brentwood and down 59% in Pacific Palisades, in the last few years. (Source: LAHSA).

This concentration of affordable housing in Venice sets a dangerous, statewide precedent. Approval of this project shows that any area of the coastal zone could become over concentrated.

4 - Community Opposition

There is overwhelming opposition to this project because of the many substantial issues. In the Spring, over 800 e-mails opposing this project were sent to the CCC South Coast office and the Venice Neighborhood Council voted unanimously to oppose this project. The attached neighborhood opposition graphic shows the vast majority of nearby neighbors oppose this project.

In addition to the points mentioned above, there are other serious issues with this project, including e-mails related to this project that were in possession of Councilman Mike Bonin's office, that were illegally deleted (as confirmed by the City Attorney's office). There were multiple members of the City Planning Commission who have relations to Safe Place for Youth and should have recused themselves. At \$500,000 per unit, this is a gross misuse of public funds that could be spent more efficiently to help more people. Spending all of the money to help a small percentage of people is not compassion; it is corruption.

Please listen to our community. Any approval of this project, as presented, would be a great injustice not only to Venice, but also to the entire state of California.



The Presidents Row Neighborhood Association is the longest standing neighborhood association in Venice, representing the area bounded by Lincoln Blvd on the east, Abbot Kinney on the west, Venice Blvd on the north, and Washington Blvd on the south.

We strongly support this appeal, as the proposed project would be detrimental to the community, and would set a precedent which would negatively affect public safety and coastal access in Venice.

The parking deficiency of 98 spaces would force residents, employees, and visitors to use the adjacent residential community for vehicle access. There would set a precedent to encourage other projects to be built in the coastal zone, and the 100% density bonus with minimal onsite parking, would place even more vehicles in the neighborhoods, further reducing coastal access.

Historically, there has been increased criminal activity and public nuisance in the community, attributed to the operations of Venice Community Housing properties, and Safe Place for Youth. Much of this has spilled onto the Venice Boardwalk and surrounding beach areas, Having on-site parking would enable SPY and VCH to better monitor the activities of their people. Putting them into the community would increase the existing problems in Venice.

This project is a bad idea. The precedent, which would be set, is disastrous.

PRNA strongly recommends that the California Coastal Commission join the residents of Venice, and the visitors who have flocked to this coastal community, in supporting this appeal.

Oppose the project

Dear Members of the California Coastal Commission,

I urge you to find substantial issue with the Lincoln Apartments project, Appeal No. A-5-VEN-20-0060.

This is a 30,463 square foot mixed used project that includes commercial, supportive services/office space and permanent supportive housing for 18-25 year olds. This project is being built with only 6 parking spaces. The Land Use Plan requires 132 total parking spaces but the project has been exempted from even providing adequate parking for the new commercial and the increased supportive services/office space because permanent supportive housing is included. It is one thing to argue that occupants of permanent supportive housing will never have cars and neither will the live in managers or janitorial/maintenance staff but the pretense that commercial and office space will not increase the need for parking is disingenuous.

Even before the expansion, the tenant (SPY) did not have adequate parking for staff and volunteers and was leasing an additional 10 parking spaces. Adjacent residential street parking was impacted by visitors and SPY clients. Doubling the size of the supportive services and adding commercial space clearly generates the need for additional parking. SPY, which will occupy the supportive space, relies not only on staff but on volunteers to provide services to its clients. Spy primarily serves youth who do not live in or near Venice. At the very least, the project should have included 16 on-site spaces to meet the existing parking need and been required to provide another 20 spaces to reflect the increase in the supportive services/office space and the commercial space.

- Zero residential parking is unreasonable and sets a dangerous precedent.
- Zero parking spaces for supportive services used by social service staff, multiple service partners and volunteers, is also unreasonable and sets a dangerous precedent.
- SPY should not receive residential parking waivers since the vast majority of their clients will be non-residents. With parking already scarce in this coastal neighborhood and a ban on preferential parking zones west of Lincoln Blvd, the lack of parking spaces provided in this project will further degrade the adjacent residential neighborhood and sets a precedent for other coastal neighborhoods across California.

The developer/tenant plans to use public parking spaces on Lincoln Blvd for loading and deliveries further reducing access to public parking. This developer also has a history in Venice of selecting sites and then asking for exemptions to parking, height and other restrictions that would normally be imposed. The result is buildings that are permanetly out of scale, out of character and non-conforming with the surrounding residential areas.

There was overwhelming community opposition to this project because of the scale and lack of parking. The Venice Neighborhood Council voted unanimously to oppose the project. Yes, we need permanent supportive housing but should it be designed and built to have an unnecessary negative impact on our community?
