DATE OF FINAL PASSAGE FEB 0 4 2019

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO CHANGING 4.44 ACRES LOCATED AT THE NORTHERLY TERMINUS OF CAMINITO RODAR, NORTH OF CALLE CRISTOBAL, WITHIN THE MIRA MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM THE AR-1-1 ZONE INTO THE OC-1-1 AND RS-1-13 ZONES, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTIONS 131.0203 AND 131.0403; AND REPEALING ORDINANCE NO. O-9030 (NEW SERIES), ADOPTED JUNE 4, 1964, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

ITEM # 53 1/29/19

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That 4.44 acres located at Northerly terminus of Caminito Rodar, north of Calle Cristobal, and legally described as a portion of Rancho De Los Penasquitos, in the Mira Mesa Community Plan area, in the City of San Diego, California, as shown on Zone Map Drawing No. B-4336 filed in the Office of the City Clerk as Document No. OO- 21042, are rezoned from the AR-1-1 zone into the OC-1-1 and RS-1-13 zones, as the zones are described and defined by San Diego Municipal Code Chapter 13, Article 1, Divisions 2 and 4. This action amends the Official Zoning Map adopted by Resolution R-301263 on February 28, 2006.

Section 2. That Ordinance No. O-9030 (New Series), adopted June 4, 1964, of the ordinances of the City of San Diego is repealed insofar as the same conflict with the rezoned uses of the land.
