A RESOLUTION OF THE COUNTY OF SAN DIEGO APPROVING THE IMPLEMENTATION PLAN COMPONENT OF THE LOCAL COASTAL PROGRAM (POD 13-009)

WHEREAS, the California Coastal Act of 1976 (Coastal Act) allows the County to assume permitting authority for development occurring within the Coastal Zone, with the exception of tidelands, submerged lands, and public trust lands; and

WHEREAS, the County of San Diego Local Coastal Program (LCP) is intended to be carried out in a manner fully in conformity with the Coastal Act; and

WHEREAS, the County adopted revised Local Coastal Program documents in 1988 and 2011; however, these documents were not certified by the Coastal Commission, and require revisions to qualify for certification by the Coastal Commission; and

WHEREAS, on September 12, 2018, the Board of Supervisors held a duly advertised public hearing on the Land Use Plan component of the Local Coastal Program and accepted the California Coastal Commission's suggested policy modifications to the LCP Land Use Plan; and

WHEREAS, on December 13, 2018, the Coastal Commission certified the LCP Land Use Plan; and

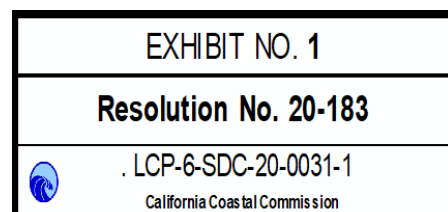
WHEREAS, on May 31, 2019, the Planning Commission, held a duly advertised public hearing on the LCP Local Implementation Plan; and

WHEREAS, the Planning Commission has made its detailed recommendations concerning the above item; and

WHEREAS, on June 26, 2019, the Board of Supervisors held a duly advertised public hearing to consider and evaluate the Implementation Plan component of the Local Coastal Program, which the Board then approved; and

WHEREAS, on November 5, 2020, the California Coastal Commission held a public hearing to consider the Board of Supervisors June 26, 2019, Local Coastal Program Implementation Plan and approved a resolution of certification with suggested policy modifications to the Implementation Plan; and

WHEREAS, the LCP Implementation Plan and accompanying Zoning Ordinance Amendments are exempt from the California Environmental Quality Act (CEQA) based on Section 15265 of the CEQA Guidelines, which exempts local jurisdictions from compliance with CEQA requirements when adopting Local Coastal Programs.



NOW THEREFORE BE IT RESOLVED that the Board of Supervisors takes the following actions:

1. Find that the preparation and adoption of the June 2019 LCP Implementation Plan is exempt from the California Environmental Quality Act pursuant to Section 15265 of the State CEQA Guidelines.
2. Receive, accept, and adopt the California Coastal Commission's November 5, 2020 resolution of certification with suggested modifications to the County of San Diego's Local Coastal Program Implementation Plan, as approved on June 26, 2019, and reflected in Attachments C and D to the Board Letter dated November 18, 2020.
3. Adopt the LCP Implementation Plan component of the Local Coastal Program that implements the Land Use Plan policies, including the policy modifications, and replace the current Zoning Ordinance coastal regulations per the ordinance included as Attachments C & D to the Board Letter dated November 18, 2020.

BE IT FURTHER RESOLVED that the Board of Supervisors hereby adopts and accepts the coastal development permit authority from the California Coastal Commission, upon certification of the Implementation Plan and subsequent certification of the Local Coastal Program.

BE IT FURTHER RESOLVED that the amended documents shall be endorsed in the manner provided by the Board of Supervisors.

BE IT FURTHER RESOLVED that Staff is directed to submit this Resolution to the Executive Director of the Coastal Commission for a determination in writing that the Board of Supervisor's actions are legally adequate to satisfy the Commission's requirements for final certification of the Local Coastal Program Implementation Plan.
