





Exhibit 2 - Project Plans

I. GENERAL NOTES:

- 1. THE CONSTRUCTION SHALL NOT RESTRICT A FIVE-FOOT CLEAR AND UNDBSTRUCTED ACCESS TO ANY WATER OR POWER DISTRIBUTION FACILITIES (POWER POLE, PULL-BOXES, TRANSFORMERS, VAULT, PUMPS, VALES, METERS, APPURTENDANCES, ETC.) OR TO THE LOCATION OF THE HOCK UP. THE CONSTRUCTION SHALL NOT BE WITHIN TEN FEET OF ANY POWER LINES-WHITHER OR NOT THE LINES AREA LOCATED ON THE PROPERTY. (PER ORDINANCE 170.158) MINUTURE ON COMMERCIAL ADDITIONS AND TIMORIC OVER \$1,000.3 SEPARATE PLUMBING PERMIT IS REQUIRED.
- 3. PROVIDE ULTRA-LOW FLUSH WATER CLOSETS FOR ALL NEW CONSTRUCTION. EXISTING SHOWER HEADS AND TOILETS MUS BE ADAPTED FOR LOW WATER CONSUMPTION.
- 4. PROVIDE (70) (72) INCH HIGH NON-ABSORBENT WALL ADJACENT TO SHOWER AND APPROVED SHATTER-RESISTANT MATERIALS FOR SHOWER ENCLOSURE. (1210.2.3, 2406.4.5, R307.2, R308.4)
- 5. WATER HEATERS MUST BE STRAPPED TO A WALL (SEC. 507.3, UPC)
- 6. SPRINKLER SYSTEM MUST BE APPROVED BY THE MECHANICAL DIVISION PRIOR TO INSTALLATION.
- 7. A FIRE ALARM SYSTEM (VÍSUAL AND AUDÍBLE) SYSTEM IS REUGÍRED. THE ALARM SYSTEM MUST BE APPROVED BY THE FIRE DEPARTMENT AND ELECTRICAL PLAN CHECK PRIOR TO INSTALLATION. (LAMC 57.122)






