Hi Erik,

Please see the email below from Karen Martin, a researcher at Pepperdine and grunion expert. While grunion haven't been reported near the project site, that is more likely because no one has ever looked and it is still possible that they run there. Karen confirmed what I suspected, which is that the beach may be appealing to grunion since they are attracted to beaches with freshwater sources.

I'm not sure if we will have time to submit comments to the Commission by tomorrow, but I wanted to make sure you were aware of this information and Karen's recommendation for monitoring just in case.

Thanks again! And hopefully both of us can get out there one day (night) for a grunion run. I've never seen one either!

Hi Amanda,

Thanks for your query. I think we have almost never heard of a person looking for grunion there, so there are no reports to provide. That does not mean they are not there of course; I've been to that site and it is appealing for that purpose. Of course you know that we have reports from Monterey Bay, San Francisco Bay, and Tomales Bay so it is within the current habitat range. Recently the grunion showed up at Bolinas on the outer coast above San Francisco, so this kind of location is possible, especially as they are attracted to beaches near streams and other outlets.

If you are looking for guidance for monitoring with a project, I would encourage you to have monitors there at least if the project occurs during the months of May, June, July or August, just in case.

Dear Chair Padilla,

The San Mateo County Chapter of Surfrider Foundation (Surfrider) is opposed to the current proposal by San Mateo County Department of Public Works (DPW) to replace the Mirada Road coastal trail bridge at the same location over Arroyo de en Medio Creek along with increased coastal armoring. Please see Surfrider's letter submitted on October 28, 2020 to the California Coastal Commission, included in the Correspondence.

# Prohibit Coastal Trail Armoring

Surfrider greatly supports public access to and along the coast – but we must not destroy the very coast that we wish to visit and walk along. When we choose to armor a coastal trail instead of relocating it, we jeopardize the very purpose of access: enjoying our natural resources and natural shoreline processes.

Armoring any coastal trail goes against the intent and direction given by the state to comply with provisions of the Coastal Act that protect public access to and along the shoreline (Sections 30210, 30211). The contention that Section 30235 justifies armoring of the Coastal Trail because the trail is a "coastal-dependent use" is inconsistent with the balancing provisions of the Coastal Act in Section 30200(b); Section 30007.5, which states that when provisions of the Coastal Act conflict with one another, they shall be balanced in such a way to be most protective of significant coastal resources. The shoreline in many areas is constantly migrating landward due to erosion and the Coastal Trail will need to migrate with the shoreline to facilitate the protection of accessible public tidelands.

The California Coastal Trail was created as part of the 1976 Coastal Act and the legislation calls for the Trail to be within "sight, sound, and scent of the sea"; that gives us room to move inland to ensure connectivity and completion. With this in mind, the staff report should not designate the trail as a "coastal dependent use," but a "coastal related" one. "Coastal dependent use" is a term that the Coastal Act section 30101 uses to define a use "which requires a site on, or adjacent to, the sea to be able to function at all." Examples of coastal dependent uses previously permitted included aquaculture, research, boating, ports and water-oriented recreation. The Coastal Commission has also designated power plants, desalination



plants and other industries as coastal dependent. But unlike these activities and structures, the coastal trail need only be sited within "sight, sound and scent" of the ocean, not necessarily immediately adjacent at all locations and at all costs.

# **Relocate the Coastal Trail Inland**

Based on the Coastal Commission's recent July 11, 2019 decision to prohibit armoring of the coastal trail at 2 Mirada in favor or landward relocation, and in light of sea level rise projections, the prudent action now is to relocate the bridge inland. The staff report concedes that the "relocation option would provide long-term protection and continuity of the CCT in light of coastal hazard impacts at the current bridge location." Despite this, the staff report accepts DPW's rejection of the inland relocation alternative.

The staff report states that inland relocation would potentially impact coastal riparian habitat. It does not, however, adequately weigh that with the ecological cost of accelerated erosion and beach loss. Both options come with ecological costs that must be fully mitigated. Special Condition 2, the Public Access Mitigation Plan is insufficient to offset the coastal resource and ecological impacts of the bridge and associated shoreline armoring. Access to and along the coast does not offset the impact of accelerated beach erosion and the complete loss of the coast itself. Coastal armoring should only be offset by creation of coastal habitat nearby. A living shoreline and/or managed retreat type project and sufficient financial resources to cover an appropriate project as such would be the only sufficient mitigation. This will maintain habitat value as well as public access and recreational value.

Additionally, the financial costs associated with moving the bridge inland aren't significantly different than the costs of rebuilding the bridge in its current location. Surfrider has encouraged San Mateo County to explore alternative routes, and specifically a route relocating the bridge over Medio Creek at Alameda Avenue, represented on Exhibit page 17, figure 4 is possible and acceptable. The County has argued that a state of urgency exists, making it necessary to reinstall the bridge at its current location, however the County knew of the need to address the bridge for an extended period of time without action.

The staff report also states that Mirada Road may eventually require shoreline armoring in a similar location as a reason to allow reconstruction of the bridge in its current configuration. However, that assumption is circumspect and has not been sufficiently evaluated in DPW's alternatives analysis or the staff report. Further, the staff report considers the threat of litigation. Should we not defend Coastal Act's shoreline armoring policies and the Coastal Commission's own Sea Level Rise Guidance because of the threat of litigation - or because local homeowners prefer not to have increased public foot traffic near their homes?



The staff report also states that the inland relocation option would take more time and financial resources to implement. We strongly encourage Coastal Commissioners to adhere to the sea level rise adaptation policy guidance and prior planning and permitting decisions that call for wise adaptation decisions now in order to preserve as much of our coastal resources as possible over the coming decades. Wise planning that will preserve our coast now and into the future requires us to make difficult decisions today.

I urge the Coastal Commission to concur with your staff's recommendation and approve a permit for San Mateo County to replace the bridge so it can be reopened as soon as fall.

Dear Commissioners,

I am a local resident and homeowner located a very short distance from the proposed Mirada Bridge replacement project. I have reviewed the commission staff report (F15a, dated 4/30/2021) regarding this project, and I STRONGLY SUPPORT THE STAFF RECOMMENDATION, which provides for replacement of the existing bridge in its current location with several conditions, including the addition of a beach access stairway at the current location.

Replacing the bridge in its current location provides many benefits which greatly outweigh the potential long-term shoreline impacts resulting from bluff armoring associated with the project (approx. 10,872 square feet of shoreline impact). This area of the coast provides abundant public access to sandy beach areas, from the Half Moon Bay State park in the south, to pillar point harbor in the north. The Mirada bridge, however, provides a <u>unique connection</u> between the southern and northern beach areas, which is not provided by the current inland detour along busy Cabrillo Highway, nor by any of the proposed alternative solutions.

In addition, many residents and visitors to this area of the coast are unable to recreate directly on the sandy beach areas, due to age or disability, or simply prefer to enjoy being near the ocean, on the coastal trail or the adjacent bluffs. Hence, retaining this vital bridge connection well serves the purpose of improving public access to a variety of coastal recreation options. Any vote against the staff recommendation based merely on the knee-jerk idea that "armoring is always bad" would be misguided and antithetical to the goals of protecting both the coast and the public's access to coastal recreation opportunities.

I strongly urge the commissioners to **vote in favor of the staff recommendations**, and issue a CDP for the project replacing the Mirada bridge.

My name is Dave Krasowski, my wife and I live at 468 Alameda Ave in Half Moon Bay. As a resident in the Miramar neighborhood, I am writing in support of the application by San Mateo County Department of Public Works to replace the bridge over Arroyo de en Medio Creek which is part of the California Coastal Trail. We appreciate the work of the Coastal Commission staff in preparation for this hearing and support the recommendations in the Staff Report to replace the bridge in it's present location.

The Miramar neighborhood has been closely following the development process for this project and has had extensive discussions with the Department of Public Works and the MidCoast Community Council on the various alternatives for replacement of this valuable community resource and strongly supports replacement in the present location. The neighborhood has collected over 1000 signatures on a petition supporting replacement of the bridge in its present location. This petition has been forwarded to the CCC.

There have been alternatives proposed which would relocate the bridge inland. The community does not support these alternatives for several reasons.

The bridge is a valuable community resource which is used by hundreds, if not thousands of people each week. The bridge has been closed for nearly a year, forcing the public to take a detour including a stretch along Highway 1 which represents not only an inconvenience but a significant safety hazard. Replacing the bridge in its present location would be the quickest way to restore access across the creek on the Coastal Trail.

Replacement of the bridge in its present location Maintains this portion of the Coastal Trail along the shoreline, rather than at an inland location.

Construction of an inland bridge would have significant impacts to the Riparian habitat along Arroyo de en Medio creek and would require study and possible mitigation.

Relocation of the bridge inland would substantially increase the cost of the project. The Staff Report estimates that the cost may more than double. The scope of the project would be increased and require environmental studies, significant re-design, and may result in legal action.

Relocation of the bridge to an inland location would seriously change the character of our neighborhood. With the temporary bypass, traffic through the neighborhood has significantly increased. A permanent inland location would require significant changes to the neighborhood infrastructure and require taking of private property to develop this alternative.

It is understood that the Coastal Commission does not generally support armoring of the coastline, which would be a component of the proposed bridge replacement. Staff has worked with the Applicant to minimize the amount of armoring required and has identified the bridge as a "pre-Coastal Act existing structure and that the Coastal Trail is coastal dependent", meaning that the project qualifies for the use of armoring under the Coastal Act. It has also been pointed out that some armoring would be required were the bridge to be relocated inland.

In conclusion, we strongly support this application and appreciate the hard work and consideration by Coastal Commission staff and the San Mateo County Department of Public Works and request that the Commission approve the Coastal Development Permit.

Dear Commissioners:

I own 438 and 408 Alameda Ave., just to the north of Medio Creek and along a previously proposed "alternate" or "inland" route for the Coastal Trail. (It was from these houses that my (now adult) children used the bridge in the 1990's to access the trail on a daily basis in learning to bike ride and roller skate.) I write briefly to provide my full support for the Staff's recommendation to replace the bridge *in situ* and as soon as possible and look forward to speaking briefly with you next Friday.

On November 18, 2020, I sent an initial, detailed letter authored by me and 15 of our neighbors commenting on the dire need to replace the bridge (this was before we were able to gather the hundreds of signatures (both local and throughout the County) that appear toward the end of your Correspondence section in the file). That initial letter can be found at p.27/186 in your file.

The Summary of Staff Recommendation (and the balance of the Recommendations) well articulate the reasons that this Application should be approved. Indeed, the Staff articulates several additional points that my letter does not adder, including that (1) even an inland re-routing would still involve some armoring and (2) Mirada Road is a pre-Coastal Act existing structure.

I respectfully refer you to our Nov. 18 letter for additional reasons to please approve the Staff Recommendation. The ultimate position we – the actual Miramar community (not outside organizations) -- took last fall was that we could not support relocating the bridge away from the water unless and until it was proven that relocation was *necessary* – that is, unless it was established that the current bridge location simply was not reasonably possible. (If that were established, we would not stand in the way of relocating down our neighborhoods because we understand and accept that the public needs access to the beach/coast area.) Now, after yet more engineering and analysis, it is clear (from the Staff Recommendation and the incorporated studies) that replacing the bridge *in situ* is *not only possible, it is the very best solution*. Relocation, on the other hand, is not only unnecessary, it would massively alter the *coastal* nature of the trail, setting a dangerous precedent (a slippery slope) to be used in future re-routing of other portions, so that over time the Coastal Trail becomes nothing of the sort.

The amendments set forth in the Staff Recommendations – including stairway access to the beach and reducing the extent of armoring – mitigate any possible negative impact from replacing the bridge. Life is not perfect but often requires compromise. The Recommendations strike the appropriate balance.

Please allow this project to proceed as soon as possible. The current detour is a disaster in the making (as well as untenable on a daily basis); the jersey barriers (and flexible upright reflectors) separating highway traffic from children riding bikes, etc. necessarily have transition gaps at intersections and otherwise pose an incredible danger. The longer the detour continues, the more likely we will have a very unfortunate incident in our neighborhood.



I am writing to express my strong support for San Mateo County's proposal and the California Coastal Commission to issue a coastal development permit, to replace, in its present location, the currently closed California Coastal Trail pedestrian bridge over Medio Creek near Half Moon Bay. I strongly agree with the Commission staff report conclusion on Page 1: "The project, as conditioned, is the best outcome possible for the public under the Coastal Act, and recommends that the Commission approve a conditioned CDP." Here are the reasons for my fervent support for replacing the Medio Creek Coastal Trail Bridge in its current location and issuance of a CDP, as soon as possible. The proposed project will:

- 1. Restore full public coastal access to a heavily used section of the coastal trail.
- 2. Significantly improve public coastal resource and beach access compared to before bridge closure.
- 3. Be the quickest and least expensive alternative.
- 4. Remove a visual intrusion and improve coastal views.
- 5. Eliminate existing danger to coastal users from falling bridge debris.

- 6. Be the least environmentally damaging feasible alternative.
- 7. Be allowed to use armoring under the CA Coastal Act as a pre-act, coastal dependent use.

One of the most important benefits of replacing the closed bridge is <u>restoring public coastal</u> <u>Access</u>. That is Access with a capital A. Prior to the closure studies by the County showed over 1,400 persons per weekend day were using the trail and crossing the bridge. Much of this access has stopped because the almost mile long and more dangerous inland trail detour has discouraged visitors and residents from using the trail to access the coast and its beaches and blufftops. The coastal trail here follows relatively flat blufftop terrain and was popular with people of all ages and abilities. Now many families, local residents and persons with disabilities turn around at the closed bridge.

Visitors and residents are ardent proponents of replacing the Medio Creed bridge right away. A clear indication of this support are the 1,128 coastal trail users who signed a petition to replace the bridge where it is, as soon as possible. We collected these signatures over just 4 days in February 2021 using volunteers at each end of the closed bridge (results were sent to CCC staff). Bridge replacement is widely popular with both visitors and with residents, as a total of 65.2% of these petition signatures were by non-residents and 34.8% were local residents of Half Moon Bay, El Granada, Princeton, Moss Beach or Montara. In fact, no trail user we spoke with was opposed to replacing the bridge and no one wanted the dangerous inland detour.

Not only will replacing the bridge restore previous levels of coastal access, the permit, as conditioned, will actual greatly <u>improve coastal Access</u> from the previous situation. The County has agreed to the staff recommendation for an accessway (stairway) down to the beach near the southeast side of the bridge. Right now, there is no safe beach access in this area. Since I live near the bridge I often get asked by a young parent holding the hand of their young child: "How can we safely access the beach?" My answer is: There is so safe access here, and they need to walk ¼ mile either direction to get to the beach. We only have a very steep eroding unofficial path which drops 40 ft, or huge rip rap boulders to navigate. The proposed plan will make the beach near the bridge much more accessible and safer to do so.

Replacing Medio Creek Bridge at its current location is the quickest and least expensive way to open the coastal trail and improve coastal access, compared to other alternatives. If the Commission approves the CDP at the May meeting, the County has indicated it has funding and will be able to complete construction by late fall. If the CDP approval is delayed it would mean another year before coastal trail connection is restored.

One part of the staff report I disagree with is on page 46 where it states: "limiting the times when work can take place (e.g., to avoid both holiday weekends and peak summer use months when recreational use is highest)" There is a very short construction window to replace the bridge so it can open in late fall. Limiting construction to outside the summer months is unnecessary, because with the bridge closed there is little public use of the immediate bridge area and the nearby pocket beach. On balance, the benefits of getting construction done and the bridge open in fall, far outweigh any disruption in the current limited amount of recreation use at the bridge site. Therefore, <u>I urge the Commission to **not** restrict construction during the summer period, except on busy holiday weekends</u>. We need to get the bridge replaced as soon as possible, and delays serve no useful purpose and just increase costs and reduce coastal access and recreation.

The proposed project will remove the visual intrusion, eliminate the existing danger to beach goers from falling debris from the deteriorated arch bridge and improve coastal views. Report page 49 states the seawalls will be sculpted, camouflaged and designed to approximate the look of natural

bluffs in the vicinity. Again, on balance, visual benefits from the proposed project will far out-weigh any adverse short term visual impacts to beach goers and coast trail users.

I whole heartedly agree with page 43 of the staff report where it states "The Commission-approved project configuration, as conditioned, is the <u>least environmentally damaging feasible alternative</u>. Conditions are included to ensure that the project will appropriately offset its sand supply and beach access impacts, and to ensure long term stability and efficacy." In addition, the report on page 48 describes how "construction will not change the current coastal dynamic at the seaward mouth of the Arroyo." Furthermore, as modified, the armoring would occupy much less beach space than the original proposal, reducing this coverage by nearly a third. There will be some impact to the coastline from armoring, but this is essential for long term bridge stability and the CCC staff have worked with the County to reduce they geo-physical impacts to a minimum.

It is critically important to note the report states on page 1: "staff has concluded that Mirada Road is a pre-Coastal Act existing structure and the CA Coastal Trail at this location is also coastal-dependent, meaning that the project qualifies for the use of armoring under the Coastal Act." Even though armoring is essential element of the proposed bridge replacement, it has been minimized and, in this case, armoring is allowed under the California Coast Act.

Therefore, I urge the California Coastal Commission to approve the conditioned CDP by San Mateo County to replace the Medio Creek coastal trail bridge in its current location, as soon as possible. Tens of thousands of visitors and local residents will thank you.
