I had a virtual briefing with the applicants' representatives, during which we discussed the proposed application for the LA Jazz Festival, an annual live music and community event to be held each August (2022-2024) on Dockweiler State Beach. As described by the applicant, the Festival includes additional free community events within and outside of the coastal zone, targeting underserved areas in the region. Over 75% of the events will be free, including the following public educational and recreational activities:

- A 2,000 member jazz & coastal youth camp on Dockweiler Beach;
- 4,000 attendees to coastal cultural tours along LA's coastline;
- 4,000 attendees to the "State of Jazz" educational conference in Marina Del Rey;
- 20,000 free attendees to Caribbean Street festival in the coastal community of El Segundo;
- 30,000 free admissions to area food & beverage establishments "after dark";
- 30,000 free admissions to free jazz "mini" concerts in public parks located in low income communities of color, and
- 25% of tickets to the two culminating days of live concerts on the beach will be free.

The applicant is in agreement with the staff recommendation with revisions to Special Conditions 1 (allowing 3 year permit term) and 3 (establishing pass and repass requirements around concert venue).
